# Sandeshkhali echoes in PM Modi's poll call for change in Bengal

ARAMBAG: PM Modi launched BJP's Lok Sabha campaign in Bengal from Hooghly's Arambag on Friday, using Sandeshkhali as a metaphor for every alleged wrong in the state, and telling women and Muslims that CM Mamata Banerjee's Trinamool Congress was working against their interest. Much of Modi's 29-

minute speech focused on Sandeshkhali, which arrested TMC strongman Sheikh Shahjahan allegedly used to lord over, and was peppered with appeals to "Bengal's mothers, sisters and daughters" not Trinamool did to Sandeshkhali's sisters and daughters crossed

BENGALURU: 'Kisan Satyagraha', a documentary on the 2020-21 farmers' protests in Delhi, has been barred from screening at the ongoing 15th edition of Bangalore International Film Festival (BIFFes) following instructions from the Union information and broadcasting ministry. The documentary is directed by acclaimed Kannada director Kesari Haravoo.According to officials, the screening of the documentary was not permitted because of its sensitive subject. "All the movies to be screened are cleared by the I&B ministry. However, the ministry did not give green signal to 'Kisan Satyagraha'... The Central authorities have told us that the matter pictured in the documentary is a sensitive subject and hence it should be withheld from being screened at the film festival. Following the instructions, we have withdrawn the screening of 'Kisan Satyagraha'. Otherwise, it should have been scheduled for screening on Friday," said G Himanth Raju, registrar, Karnataka Chalanchithra Academy.





# These customers hadn't bargained for a blood-splattered platter for lunch

BENGALURU: It was expected to be a packed afternoon with working professionals in the tech corridor chilling out, munching on crispy dosas and fluffy idlis. Security guard Ramesh positioned himself near the entrance of The Rameshwaram Cafe, prepared to handle the rush. But as he turned around to attend to a customer, there was an earshattering blast behind him.

"I couldn't hear anything for the next 15 minutes," Ramesh told. "The impact was such that I felt like pulling my ears apart to end the deafening sound ringing inside me. I looked around to see the place filled with thick smoke. While some people ran around, some were on the floor. I couldn't come to terms with what was happening." Ramesh was one of the

dutv at The Rameshwaram Cafe, located in Brookefield area near the busy ITPL Road. There were around 250 customers at the restaurant when the explosion took place around 12.55pm on Friday. When he learnt it was actu- ally a bomb blast, Ramesh folded his hands and thanked God for keeping him and others alive. Shabareesh, an employee of a local firm, said, "We colleagues had planned a luncheon and were waiting outside the hotel for some others

to arrive. Suddenly, all of us were rattled by a huge sound. Soon, the entire restaurant area was covered in thick black smoke and people were struggling to come out.

A few of us rushed towards the restaurant and saw small pieces of the granite flooring had chipped off and hit the glass panel and wall. The smoke made things suffocating. A few customers and staff were spotted with bleeding injuries and we rushed them to a hospital by arranging autos." Amrut, an

admin officer at a software firm nearby, said he had a miraculous escape. "I was waiting for my friends at the hotel after ordering dosa. I had just walked away from the counter when a loud noise was heard from near the coffee/tea counter and thick smoke covered entire the area. Eatables and utensils strewn were all around. We could see a small crater at the place from where the blast sound was heard. The partition wall of glass between the juice, coffee counter and the main entrance was reduced to pieces."

Sachin Lamani, another guard at the hotel, said, "Despite the thick smoke, a few of us managed to enter the hotel and saw 4-5 injured people, including our staffers. A woman was bleeding from the right shoulder where glass pieces had pierced her.

On December 12, 2023, NGT instructed states and Union territories to analyze groundwater samples for arsenic and fluoride. The tribunal

## World's largest stainless steel structure

Hyderabad now has the world's largest seamless stainless-steel memorial-the Telangana Martyrs Memorial, or Amara Jyoti. Dominating the landscape for miles and close to the State Secretariat, the elliptical-shaped structure has a giant, yellow flame in carbon steel atop it. The memorial has been built as a tribute to those brave people who gave up their lives over the past five decades, or so, for the statehood of Telangana. This international distinction didn't come easy. Amara Jyoti has been four years in the making. Prior to this, the conceptualisation and ironing out of the logistics took two years; hence, it necessitated altogether six years. The construction began in 2019, and it was inaugurated in June, 2023. It also took a huge amount of manpower. Over 5,000 construction labourers (approx), around 100 engineers, and 500 technicians contributed to making this memorial plan a reality. About 4,500 stainless-steel plates, weighing over a hundred tonnes, were used for the structure, along with other materials. Finally, it cost nearly Rs 180 crore. However, it was an investment eminently worth the cost and effort for the state government and the workforce, considering that it holds so much symbolic value. The steady stream of visitors that are pouring in is also appreciating this monument. The crowds are getting bigger considering it is located in the central part of the city and beside the famous Hussain Sagar Lake. The memorial is spread over a total area of 3.29 acres of land. There is a large, well-landscaped garden, and the memorial structure with its highly polished, reflective exterior stands within this green space. The built-up area of the memorial, including the garden, is about 2.88 lakh sq feet (26,800 sq metres). The artistsculptor who developed the concept, designed the memorial, and also supervised the project from start to finish, K Venkata Ramana Reddy, explains that he already had exposure to many famous monuments, including memorials around the world in 80 countries, but, for the purpose of this project, visited many countries to study the kind of war memorials they had.

"I submitted five designs, of which the one you see was approved by the Telangana state government," he reveals. The stainless-steel material (316 L) was procured from Sweden. The 4,500 sheets were assembled into approximately 450 large plates in Dubai and shipped to Hyderabad in containers. Here, onsite, these stainless-steel plates were assembled, i.e., welded together with flawless precision and laser technology, to create a smooth, seamless exterior with a mirror-like finish. Of course, the interior walls and slabs used concrete. Globetrotters may find the Amara Jyoti somewhat reminiscent of the famous Chicago Bean or Cloud Gate and the Bubble at Karamay in China. However, Ramana Reddy is quick to rebut the comparisons, though he does appreciate the Chicago Bean. As he points out, "The Chicago Bean or Cloud Gate is a public art project and not a memorial. Moreover, it is smaller in length, breadth, and width." The Bubble is widely considered a copy of the Chicago Bean design. Making Amara Jyoti was a very tough task and required painstaking attention to detail, explains Ramana Reddy, reeling off more statistics. The base of the lamp, or diya, has an elliptical shape with a major axis length of 54 metres and a minor axis length of 37 meters. From the terrace, the diya rises to a height of 26 metres and is 45 metres from ground level. The Amara Jyoti is a seven-story structure, including the cellars. The steel structure has four floors. Coming up soon are other features like a museum, convention centre, audio-video hall, cafetaria, restrooms, escalators, parking facilities, etc.

# Border villages of Nelang and Jadung, near the Line of Actual Control

**Though** historically intimately linked, two separate events took place recently, nearly 1,000 miles away from each other. e central sector of the Indo-Tibet boundary in Uttarakhand, Chief of Defence Staff (CDS) General Anil Chauhan directed Army formations to work for the rehabilitation of the border villages of Nelang and Jadung, near the Line of Actual Control in Chamoli district. During the 1962 Indo-China war, both villages were abandoned, and their residents were relocated to safer nearby areas.

Far away in the east, at the Tawang War Memorial in Arunachal Pradesh, the Indian Army, along with the Tawang administration and the local Monpa population, commemorated the 74th anniversary of the arrival of Maj Bob Khathing in the area In 1951, the Manipuri Naga officer took over the administration of the border town of Tawang, south of the McMahon Line; a communiqué of the Defense PRO in Guwahati thus explained, "After the valiant Major undertook a treacherous march from the plains of Assam to Tawang, negotiating Sela and Bomdila passes during peak winters, leading a contingent of 200 Assam Rifles troops and 600 porters for a difficult maiden mission, thus materialised the formal



establishment of Indian civil administration at Tawang." The above two events are linked as the takeover of both places' administration is the result of a decision of the Himmasinghji Border Defence Committee created by the Army Headquarters on November 12, 1950.

Precise tasks were given to the young and bold officer. The first task was to occupy Tawang. Khathing was asked to explain to the local population and Tibetan officials that he was "doing no more than is being done by the administration in other parts of Indian territory;" in 1914, Tibet had agreed to the McMahon Line, north of Tawang being the boundary. The major was ordered to "treat any Tibetan or other officials you may meet with courtesy, but nevertheless let

them understand that juris-

diction in the area vests in you and not in them." He was directed to submit detailed reports about the Tibetan 'influence' in the area and the nature of taxes collected. He was further told to abolish all existing taxes and substitute them with lighter taxes to be paid to the Political Officer, representing the Indian government: "There will be no forced labour and everything needed will be duly paid for." An important task was to communicate to the local people that "none of their religious practices The sixth point was that in case Khathing met with armed opposition, he was to cable Shillong (the governor's office) immediately, "indicating the strength and position opposing forces." of Fortunately, due to Khathing's intelligence and diplomatic skills, this would not be nec-

essary, and 74 years later, he was still considered by the Monpas as their liberator. Khathing was also asked to keep daily wireless telegraphic contact with Daulatram after crossing the Se-La pass. It is what Khathing did, and his dispatches and cables still make fascinating reading.

### Let us remember the facts

On October 7, 1950, the communist troops advanced in eastern Tibet, and after smashing the ill-trained and ill-equipped Tibetan army, Chamdo, the capital of Kham Province, fell to the invaders. On November 7, Sardar Patel, the deputy prime minister, despite his poor health, sent a long letter to the prime minister about the implications of the Chinese invasion of Tibet for India's northern border. Five days later, the dying Sardar (who passed away on December 15) constituted this committee to examine the possibility of Chinese communist troops occupying the areas south of the McMahon Line or elsewhere on the Indo-Tibet border and "to consider the feasibility or advancing outposts of the Assam Rifles in order to forestall such ingress".

### The Role of Jairamdas Daulatram

One man was central in the setting up of Maj Khathing's expedition to Tawang; it was Jairamdas Daulatram, the governor of Assam. It is sad that his role has been more or less forgotten today. On December 10, 1950, he managed to get the concurrence of the Ministry of External Affairs headed by Nehru; a Joint Secretary concurred with the Committee, "We cannot agree to a unilateral occupation of Tawang by the communists."

The ball then started rolling, and preparations for the expedition began. Maj Khathing received detailed instructions from Nari Rustomji, the advisor to the governor, on behalf of Daulatram himself.

# Ukrainian resistance on the outskirts of Kyiv

In the book 'The Fathomless Caves', Kate Forsyth, the author, describes war as, "An unpredictable beast. Once unleashed, it runs like a rabid dog, ravening friends and foes alike. It can drag on for years, a slow attrition of nerve and fortitude, or be over in one brilliant flash, an extravagant configuration of flame and blood and sweat." The Russian-Ukraine War fits well into the above description.

When President Putin launched 'special military operations' to 'demilitarise and denazify' Ukraine on February 24, 2022, it was universally given that the war would be over in a few days, with Russia

inflicting a crushing defeat on from Crimea, and the south- recapturing Kharkiv and Ukraine.Ironically, two years later, the conflict rages on, degenerating into a state of stalemate with little change in the ground situation. Although a classic limited war, its politico-economic impact has been felt far and wide, with serious geo-strategic ramifications. Militarily, it has gone on to redefine the very nature of warfare. The Russian offensive commenced as a typical military campaign, preceded by missiles and airstrikes, followed by a large-scale ground invasion along multiple fronts. The northern thrust was launched from Belarus towards Kyiv, the southern one was

eastern push was from Kherson by November, thus Luhansk-Donetsk towards Kharkiv. . In the wake of heavy losses and stiff Ukrainian resistance on the outskirts of Kyiv, the Russian Northern thrust stalled within a month, towards the end of March. By April, the Russian Army had retreated to consolidate gains around the Luhansk and Donetsk areas. However, the Russians did succeed in capturing Mariupol in May after a prolonged siege. Having stabilised the situation, in August, the Ukrainian forces launched a limited counterattack in the south and a month later in the north-east, succeeding in

forcing the Russians to withdraw east of the Dnieper River. With winters setting in, the pace of operations had slowed down. The Ukrainians resorted to launching a number of drone strikes against the Russian bases. A period of lull was used by the belligerents to consolidate their positions and gear up for the next phase. By the end of 2022, around 8 million refugees had fled Ukraine. Both sides had suffered heavy casualties; more than half a million Russian and Ukrainian soldiers were killed or wounded, besides over 10,000 civilian fatalities.

# Air India was fined Rs 1.10 crore by the DGCA for safety infractions

The aviation regulator DGCA fined Air India Rs 1.10 crore for operating Boeing 777 aircraft that were leased to the United States in breach of safety regulations. This is Air India's second penalty in a week from the regulator. A former Air India pilot filed a complaint with the regulator, claiming that the airline was operating Boeing 777 aircraft to the US without the necessary emergency oxygen supply system The in place. Directorate General of Civil Aviation (DGCA) conducted a thorough inquiry into the situation and served the airline with a showcause notice. "Since the said operations of the leased aircraft were not in line with regulatory/ OEM (Original Equipment Manufacturer) performance limits, DGCA has initiated enforcement action and imposed a penalty of Rs 1.10 crore on Air India," according to a notification from Air India did DGCA. not immediately



respond to inquiries regarding the punishment. The announcement said that following receipt of a voluntary safety report by an airline employee accusing Air India aircraft on specific longrange terrain-critical routes of safety violations, the regulator conducted a thorough investigation. A showcause notice was sent to Air India, according to the DGCA, since the investigation's first findings suggested the airline was not in compliance. The press release

omitted certain details. Before pursuing enforcement the DGCA action. examined the airline's answer to the show

cause notice in light of the performance limitations outlined in the documents provided by the OEM and the requirements outlined under applicable statutory provisions, according to the announcement. The pilot, who had been a commander, B777 lodged a complaint with the airline on October 29, 2023, over its policy of not having the necessary emergency oxygen supply equipment on board.

According to reports at the time, the issue was that Air India was using leased B777 aircraft on flights that had a chemically manufactured oxygen system that lasted for around 12 minutes.

However, no corrective measure has been taken, indicating that the authorities have learnt no lessons despite accidents at these unauthorised factories and godowns happening on such a large scale. None of these places has a noobjection certificate from the fire department but that has not proved to be deterrent for them as they collude with other authorities and function without any hinderance. Data shared by the fire department has revealed that in 2022 and 2023, there have been around 400 fire incidents every year. Fifty-four cases of facto-
