Delhi coaching centre deaths: SC directs Centre-appointed panel to submit interim safety measures within 4 weeks

NEW DELHI: The Supreme Court on Friday directed the Union government to establish a high-level committee tasked with submitting interim safety measures within four weeks, following the tragic deaths of three IAS aspirants in a coaching centre basement Delhi's Rajendra Nagar area in July.

The bench, comprising Justices Surya Ujjal Kant and Bhuyan, also instructed the governments of Haryana, Uttar Pradesh, and Delhi to inform the court of any policy, legislative, and administrative changes implemented to prevent similar incidents from occurring in the future.

The bench also pointed out the necessity for consistent safety initiatives across the



Region (NCR) to avoid another tragedy like the one in Old Rajendra Nagar.

On August 5, the Supreme Court had expressed serious concern over the safety of students in coaching centres, noting that they were rapidly becoming "death chambers. The court had issued notices to both the Central and Delhi governments, urging immediate action. The matter gained judicial attention when a coaching centre association challenged a December

2023 Delhi high court

order, which required inspections of all coaching centres in the capital to ensure compliance with fire safety norms. The apex court dismissed the association's plea, deeming it frivolous, and imposed a penalty of Rs 1 lakh. The bench clarified that no coaching centre should operate unless they meet fire safety standards and other essential regulations. To further ensure transparency, the Delhi high court had transferred the investigation from the Delhi Police to the Central Bureau of Investigation (CBI),



TURF WAR PLAGUES PRAYAGRAJ SCHOOL

Prayagraj: Boys High School and College (BHS), one of Allahabad's oldest and most prominent educational institutions, boasts of producing luminaries such as former Prime Minister Vishwanath Pratap Singh, Supreme Court Judge Markandey Katju, and actor Amitabh Bachchan is caught in a fierce tug of war. On one side is Bishop Morris Edgar Dan of the Lucknow Diocese, and on the other is Principal DA Luke, who doubts the Dan's locus standi in school operations. Tension had been building up after Morris recently took over as Bishop. Principal DA Luke is adamant that Morris Edgar Dan had nothing to do with BHS and was attempting to preserve an institution to which he had dedicated valuable three decades of his life. "The Bishop was out to destabilise me by creating rumours. This has created a lot of confusion among the community members too, but I will not allow anyone to damage the nearly 200-year-old institution, he said.

Boys High School Principal David Andrew Luke (DA Luke), son of late R.A. Luke, has shot off a letter to the Chief Minister Yogi Adityanath to clear false allegations against him in case involving his alleged M.A. Marksheet Roll No. 361222/2007 and to cancel a fraudulent complaint filed by Morris Edgar Dan at Police Station Civil Lines, Prayagraj.

In his letter to the chief minister, he claimed that Morris Edgar Dan prepared marksheet Roll No. 361222/ 2007 of M.A. Chhatrapati Shahu Ji Maharaj, University of Kanpur, in the applicant's name, and that the University of Kanpur falsely certified that this marksheet was not of David Andrew Luke's. Dan appointed himself Chairman using a falsified letter in collusion with the Assistant Registrar, resulting in the High Court staying Writ Petition No. 12640/2024.

In addition to this, the applicant presented the First Information Report of the movement of Rs 3 crore 84 lakh at the Civil Lines police station, whose crime number is 315/2023, and the applicant's protest application is now being considered by the CJM court. Because of the aforesaid presentation, Morris Edgar Dan prepared a forged marksheet, which was fraudulently authenticated, and an application was made to write a fake initial information report, which was published in the press after distorting all of the records. In this respect, the petitioner provided an oral statement to Inspector in Charge, Civil Lines, and Outpost Incharge Deepak Kumar.

The aforementioned marksheet, submitted by Morris Edgar Dan and bear-**IGRS** 40017524041487, does not belong to the applicant, nor is he linked to it. The applicant did not obtain an M.A. from Chhatrapati Shahu Ji Maharaj University, Kanpur in 2007. The aforementioned mark sheet was

falsely fabricated by Mor-

ris Edgar Dan with the goal

of taking over the school and ruining the applicant's reputation. David Andrew Luke, son of late R.A. Luke, filed a first information report with the Civil Lines police station against Morris Edgar Dan for defrauding and destroying the applicant's reputation.

He has urged that the Chief Minister to direct the Police Commissioner Prayagraj and the Inspector in Charge of Civil Lines to file the applicant's first information report.

He stated that the M.A. marksheet questioned by Morris Edgar Dan, roll number 361222, year 2007, is not at Police Station Civil Line Prayagraj, as well as a case in court, which is still pending. In order to avoid having to repay the abovementioned money, Dan scanned marksheet fraudulently. And incorrectly copied appointment letter forms, among other things, are ruining the institution's almost 200year-old reputation. The school's adminis-

tration system is still a question. Since 2015, the Bishop of the Church of North India has not been the lawful chairman, and Morris Edgar Dan has illegally declared



his, and he has nothing to do with it. Morris Edgar Dan and his gang produced the marksheet to ruin the reputation of the BHS principal. In this regard, he has requested the Chief Minister and Director General of Police to file a First Information Report on the creation of fake mark sheets.

Morris Edgar Dan and his team withdrew Rs. 3,84,00,000 from Axis Bank, which was the amount returned to the school by income tax department. In the aforementioned instance, Dan went to jail and was released after reaching a compromise, but did not refund Rs. 3,84,00,000. Against this, Luke filed a himself chairman, whose writ suit No. 12640/2024 has been stayed by an order. He is not the school's chairman or involved in any way. The appointment of Morris Edgar Dan is also being opposed by Bishop John Augustine who is still legally the Chairman of Allahabad High School So-

Morris Edgar Dan is embezzling crores of rupees not only from BHS but also from other schools through fraudulent invoices. No principal can resist them out of fear of losing their job. Luke has filed an application with the Chief Minister to stop the use of fraudulent mark sheets

when filing the First Information Report. As a result, it is recommended that the previously published news be modified in order to present the actual facts to society. The so-called Bishop

Morris Edgar Dan filed a bogus case against the applicant based on forgeries. In this regard, a dispute over the school's management, approximately a dozen petitions are pending before the High Court, preventing the so-called Bishop from declaring himself as Chairman of the school, and the applicant has previously filed fraud charges against him. A complaint of eviction was launched, and since 2015, the so-called former Bishop has been attempting to designate himself Chairman of the school/institution (The Allahabad High School Society) using falsified documents and no legal author-

Even before this, the socalled Bishop and his gang filed numerous false complaints against the applicant based on forged documents, prompting the Registrar Firm Societies and Chits Prayagraj and Minority Commission to issue a show cause notice to the applicant, which was postponed by the High Court's order. When the aforementioned individuals were unable to take action against the applicant, they created a counterfeit application form as well as a phony appointment letter and mark sheet for the applicant, which had previously been created by the so-called Bishop Morris Edgar Dan and his gang. The aforementioned individuals made the false appointment. Just glancing at the letter, it looks to be forged.

The people in question want to take over the school by whatever means necessary, which is why they fabricated this bogus assertion. These persons filed this complaint only with the goal of exerting pressure on the applicant and taking over the school, which is utterly untrue and deceptive, and is based on fake documents created by the aforementioned people. The applicant's appointment and all educational certifications are real and proper, as have been done many times in the past by senior authorities affiliated with the education department. They have complete authority to perform the inquiry and determined that all of the applicant's educational certifications are accurate and correct.

As a result, the applicant's appointment letters from Bishop Morris Edgar Dan and his gang are absolutely false. It is very required in the interest of justice to record the applicant's statement in response to the complaint and to file a case against the aforementioned individuals for submitting fake paper-

France offers a welcome breather for India

Prime Minister Narendra Modi with chief guest French President Emmanuel Macron during the 75th Republic Day parade, at the Kartavya Path, PTI Between them, US President Joe Biden and rival Republican Party's Nikki Haley seem bent on pushing India closer to France for a balanced relationship in the western world that has all the ingredients of strategic stability, both in the bilateral and multilateral contexts. That is if one were to leave out India's Russia relations, which many believed were rocky but became sort of rock steady all over again owing to the Ukraine War, where the long American arm was seen all over

Yes, Nikki Haley, 51, is not even Biden's likely rival in the US presidential polls in November. She did not mean to question, challenge or rebuke India, either. Instead, by claiming that India was moving closer to Russia than the US, implying that the Biden presidency did not inspire confidence not only in New Delhi, but also in Tokyo and Seoul, Canberra and Wellington, Halley was only targeting the incumbent back home. But her choice of India, and not any of America's NATO allies, for example and her choice of words, gave the impression that she was trying to convince a certain section of Republican voters that she was all American, and not Indian.It has to be front-runner and former president Donald Trump. Halley is trailing the Republican primaries and polled lower than their kind of NOTA in Nevada, but that does not make sure that Trump's name will be on the ballot. Indications are that at some point, either the Republican Party bosses or American courts could make it embarrassing for Trump's name to be on the ballot. Halley seems hoping for that day and is persisting in the primaries precisely for this reason. Maybe, like a typical Indian-origin woman that she is, Halley is hoping for 'sympathy votes' or 'survivor's votes', first in the primaries and later in the presidential poll. Of course, there is a long way to go this time than any time in the


Disappointment for India

Biden kept India waiting and eventually turned down the invitation to be the chief guest at the annual Republic Day celebrations. Information about India's invitation having spread after a time (generally it is kept secret until accepted – which again used to be a formality), Biden's avoidablydelayed rejection was a disappointment for India. It is not known how the Indian-American supporters of Biden and the Democratic Party feel about it. Not-so-official news sources claimed that Biden's decision owed to the election year commitments on campaigns and other essentials. In his place, another Democratic president. Barack Obama, took a short break from his socalled pressing engagements back home to be present in Mumbai first and Delhi next, where he was the chief guest at the 2015 Republic Day. Of course, in true American form and style, it was not a visit confined to honouring contemporary India's tryst with destiny. Obama did hard-selling business in an election year and took back orders for Boeing, which he said would ensure 20,000 Americans did not lose their jobs. Biden was constrained by domestic perceptions, both inside the Democratic Party and outside.Maybe, Team Modi too thought that having Biden would be a high-profile commencement to the ruling BJP-NDA's campaign for the Lok Sabha polls in the summer. To an extent, it compares with the 'Namaste Trump' show that India put out for the US President of the time, in February 2020 amid the farmers' rally in New Delhi. The Ahmedabad rally in particular was only a mirror-image of the Trump show for the Indian prime minister, 'Howdy Modi' in Houston months earlier in Houston, Texas.

Narasimha Rao was a Batman of Indian politics, Bharat urgently needed to acknowledge

Former Prime Minister PV Narasimha Rao, in a true sense of the word, was a Batman of Indian politics. He became Prime Minister at a time when India's chips were badly down. In 1991, the country had to pledge its gold to pull the economy from the brink. He reoriented India's pro-Soviet Union foreign policy to bring it closer to the Western order. He reached out to Israel without leaving the Palestinian cause — an axis on which the Indian foreign policy still revolves around. And all this he delivered with a minority government. Still, Narasimha Rao remains largely forgotten and uncredited — Batman-like. Sanjaya Baru, in his book 1991: How PV Narasimha Rao Made History, emphasised at this phenomenon, with a tinge of sadness, when he recalled how "at an interaction with students at a university near Delhi, in the winter of 2015", he asked the audience "what the year 1991 meant to them". One student readily stood up to say he was born that year — and the entire audience burst into laughter. When Baru insisted on thinking more, there was silence.

PV Narasimha Rao, Charan Singh, MS Swaminathan: Why they deserve Bharat Ratna Later, the same year, Baru addressed "a meeting of the Hyderabad Management Association" and he repeated



the same question. Many were quick to reply this time: The government that year had "introduced new economic policies that opened up the Indian economy", Baru was told. And who was responsible for this? "Manmohan Singh," pat came the reply! Some even credited P Chidambaram and Kamal Nath! Later, in an interaction with this author, Baru expressed his surprise at the height of Indian ignorance: "No one mentioned PV Narasimha Rao. Ironically, this incident took place in Hyderabad, which was Rao's own city."

When I asked Baru why Rao had been forgotten, he cited two reasons. "One, he faced several corruption cases, especially towards the fag end of his rule. But most importantly, the Congress decided to erase the memory of Narasimha Rao, to make the point that no person from outside the family can ever be a successful PM. After all, what did Rao prove? He

proved that someone doesn't need to be related to the Nehru-Gandhi family to be a successful prime minister. By becoming the first PM outside the family to run the country for a full term, he effectively challenged this notion."

It's ironic to see the Congress disowning one of its own prime ministers, especially the one "whose impact on the nation's fortune went way beyond the economy", as Baru wrote in 1991. But then it was an obvious outcome for a non-Gandhi leader in the Congress. It had happened in the past with Sardar Vallabhbhai Patel and it took place after Narasimha Rao, as was the case with Pranab Mukherjee. Anyone seen to be eclipsing the halo of the Gandhi-Nehru family was systematically targeted to be pushed to the footnotes of the party's — and by extension, the nation's — history. This explains Sonia Gandhi's hostility for Rao, to the extent that the former Prime Minister was denied a well-

deserved memorial in Delhi, even when lesser worthies could find space in the national capital. NEW DELHI: The official YouTube channel of the Supreme Court of India was hacked on Friday. The incident came to light when a blank video titled "Brad Garlinghouse: Ripple Responds To The SEC's \$2 Billion Fine! XRP PRICE PRE-DICTION" went live on the channel. Brad Garlinghouse is the CEO of Ripple Labs, a company that has been in legal disputes with the Securities and Exchange Commission (SEC). The hackers also seem to have made earlier videos of Supreme Court hearings private.

How first Indian astronaut in 40 years is prepping for space

In the spring of 2025, astronaut Indian captain group Shubhanshu Shukla is set to make history as the pilot of the Axiom-4 (Ax-4) mission that will mark India's first human presence on the International Space Station (ISS). Mamata blames ally Soren for flooding, closes border

KOLKATA/BURDWAN/R ANCHI: Bengal's battle with floods triggered a face-off with Jharkhand Thursday after CM Mamata Banerjee ordered the sealing of the inter-state border, accusing Damodar Valley Corporation (DVC) of swamping 11 south Bengal districts with 5 lakh cusecs of water in three days despite her appeals to the PSU and counterpart and INDIA bloc ally Hemant Soren. Mamata declared her government was "severing all ties" with DVC, which operates in both states, for "flooding Bengal Jharkhand"."It's a hasty and unreasonable move by Bengal," JMM general secretary Supriyo Bhattacharya said. "We will block all goods trucks carrying foodgrain and other commodities to Bengal. Water levels in Jharkhand's reservoirs were nearing the danger mark due to heavy rain. In any case, an interstate committee monitors release of water from overflowing dams.' 'It is as per norms'

DVC biased towards Jharkhand,



Mamata Baneriee While Mamata said the border was being closed to pre-empt cars being swept away by surging floodwaters on this side of the border, Soren-led JMM threatened retaliation over Bengal Police barring trucks and other commercial vehicles from Jharkhand beyond Dhanbad-West Burdwan border in Kulti. "I called DVC chairperson (S Suresh Kumar) and spoke to Jharkhand CM Soren, urging them not to release water... This cannot be allowed," the CM said, pointing out that 26 people had died in the floods and 2.5 lakh people displaced. Mamata alleged that DVC hadn't been providing details of how much water was being released from dams in the neighbouring state. Senior officials in several

of Bengal's westernmost

districts said police checkpoints had been set up along the border with Jharkhand and all inbound vehicles were being stopped, barring any emergency.

Mamata, who visited Midnapore's East Panskura and Howrah's Udaynarayanpur Thursday to survey the flood damage, later held an emergency meeting at the state secretariat with chief secretary Manoi Pant. DGP Raieev Kumar and other senior officers. "Even Durga Puja pandals are under water," the CM said.

"Why should Bengal always suffer? Why will DVC always try to keep Jharkhand safe? I need to protect Bengal," she said. "This flooding is not because of rain. It is because of the absence of any desilting or dredging despite my appeals to PM Narendra Modi."



Is a state law hiking levy binding on central govt?

NEW DELHI: States will keenly watch the tussle between Punjab and Centre in Supreme Court at the core of which is a larger question - whether a state legislation increasing the fees charged for the process of foodgrains procurement for central PDS schemes would be binding on Union government. Punjab had increased the levy to 6% of MSP of the total foodgrains procured from the state but Centre agreed to reimburse only 2% levy, uniformly applicable to all states, towards procurement process cost. This state levy, reimbursed by Centre to states, is over and above the cost of foodgrains it pays to states. These foodgrains are distributed free or at subsidised prices to weaker and vulnerable sections of society under the Pradhan Mantri Garib Kalyan Anna Yojana, Antyodaya and argeted Public Distribution System. Raising a Centre-state dispute under Article 131 of the Constitution on the Centre's refusal to reimburse 6% levy mandated under state laws, Punjab has taken a stand that "the state holds exclusive power to determine the statutory charges to be levied on procurement of foodgrains on Centre's behalf". Centre refuted the assertion and said, "There is no legal right under any parliamentary law which requires Centre to consider, or act upon such determination of levy by a state... As per the MoU entered by the states and Centre, Union govt is entitled to determine the rates concerning procurement of foodgrains for distribution under central schemes." Punjab govt said it was utilising the two levies of 3% each market fee and rural development fee - solely for the purpose of rural infrastructure such as improving approach roads, clean drinking water and maintenance of storage facilities, and for promotion of agricultural produce.

India extends \$50 million budgetary aid to Maldives for another

NEW DELHI: India has Government extended budgetary support to the Maldives by rolling over a \$50 million Treasury Bill for anothat the er year Maldivian government's request. The Indian high commission in the Maldives announced this extension on Thursday, facilitated by the State Bank of India (SBI).

The SBI has subscribed to the \$50 million government Treasury Bills (T-bills) issued by the Maldives' Ministry of Finance for an additional year, following the maturity of the previous subscription on September 19.

This marks the second such rollover by the Indian government this year, with the first occurring in May. The Indian high commission said, "Earlier in May 2024, SBI had similarly subscribed a \$50 mn T-bills under same mechanism, again on

Maldives. These subscriptions have been made at the special request of Government Maldives as emergency financial assistance."The Indian high commission emphasized the significance of the Maldives in India's regional policy, noting, "Maldives is India's key maritime neighbour and an important partner under India's 'Neighbourhood First' policy and Vision SAGAR i.e. Security and Growth for All in the Region."India has also extended a special quota for the export of essential commodities to the Maldives for another year. Pheran for PM Modi, fairytale for farmer

NEW DELHI: When PM Narendra Modi addressed a poll rally in Srinagar on Thursday, he wore "pheran", which had a riveting tale of an Anantnag-based farmer gifting him the traditional Kashmiri robe.Irshad Hussain Naikoo, a farmer from Anantnag, recalled how he overcame obstacles to weave a pheran for his "ideal" leader, and the joy he felt when PM Modi wore it at an event in Srinagar. Naikoo dreamt of meeting PM Modi since 2013. Despite his financial hardships, he always wanted to give something special to the PM. In a video message, he said: "I admired Narendra Modi for a long time and wanted to meet him. In 2013, I started saving money to buy him a gift. After a few years, I decided to make a pheran, the traditional Kashmiri dress, for the PM." "I bought a good fabric with the money I had saved. But there was a challenge-I didn't know PM Modi's measurements. Then it came to my mind that my father has a similar build.

So, I took my father to the tailor. With his measurements, I explained exactly how I wanted the

pheran to be made," he said.

Joe dramatically raises US tariffs on Chinese EVs

Delhi: US President Joe lambasted Biden Beijing for "cheating" as he raised tariffs on Chinese products such electric vehicles and semiconductors. Beijing strongly opposed the sanctions as Biden sought to appear tough on trade ahead of a rematch Republican Donald Trump in November's US presidential election. "We're not going to let China flood our market, making it impossible for American automakers to compete fairly," Biden declared in the White House Rose Garden. He said, "We're never going to allow China to unfairly control the market for these cars," before ordering duties. Trump's tariffs have been frequently criticized by Biden. He's been using similar tactics to win over bluecollar voters in swing Rust Belt states. The White House stated EV tariffs will treble to 100% this year and semiconductor duties will rise from 25% to 50% by next year.



File ITR or risk scrutiny

Delhi: A taxpayer will be investigated if they do not file an income-tax return after an inquiry notification. This notification under section 142(1) is provided when a taxpayer has not submitted the tax return or to request preliminary information about a detail such as bank interest or long-term capital gains/loss on property sale. This advice is part of the Central Board of Direct Taxes' new comprehensive rules for mandatory I-T return selection for complete inspection. Annual guidelines cover survey, search and seizure, tax evasion, and cases where no I-T return was filed in response to an inquiry notification for the current financial year (selection and thorough inspection). It also includes non-registration or termination of registration under sections 12A/12AB for charity organizations seeking tax benefits. In addition, if the taxpayers' income increased on a recurring issue in an earlier year, the I-T return will be picked up under obligatory inspection standards, subject to monetary restrictions. "The guideline states that all I-T returns filed during FY24 will have the outer time limit for issue of a notice by June 30, 2024." In selective cases, complete scrutiny is performed to ensure the taxpayer has declared income correctly and paid taxes.

AIIMS to open emergency cath lab



Delhi: The All India Institute of Medical Sciences will open a cath lab for emergency patients to provide primary neuro, cardiac, and endovascular procedures in the "golden hour". The emergency department has no specialized Cath Lab. After considering the patient load and the require-

ment for fast actions, especially in emergencies, this strategic option was made. Officials noted the number of functioning Cath Labs falls short of meeting rising demand, resulting in longer wait times for sophisticated brain and cardiac treatments. Lack of a dedicated Cath Lab in the

at the facility. Delhi's top electoral officer P Krishnamurthy said this collaboration will promote voting and reduce transportation

"We offer free bike rides on election day to make voting easier and encourage folks to vote. Every vote counts, so eligible voters must vote without obstruction, "Krishnamurthy added. The facility will supplement the pick-up and drop-off for disabled and elderly people. The weather department predicts a strong heat wave on May 25, so election officials are planning to boost voter turnout.



Close fire-violating coaching centers: HC



Delhi: The Delhi High Court ordered MCD and DDA to close Mukherjee Nagar's tutoring centers that violated fire safety rules. A team of lawyers revealed that various MCD-claimed actions continued to operate, prompting Justices Yashwant Varma and Ravinder Dudeja to issue the instruction. The bench heard a number of coaching centre petitions, including one it filed after noticing a fire at one in Mukherjee Nagar last year. The amicus claimed numerous premises violated fire safety rules, and one had an electrical board at the door that blocked fire escape. . "In light of apparent violation of sealing directions issued by us, we direct MCD/DDA to take action forthwith." HC also clarified that a building's "character" for identification as an educational building and fire safety norms must be determined by its "use" and asked MCD, DDA, and Delhi Fire Services to conduct a new survey within four weeks to identify non-compliant centres.

The court ordered all tutoring centers to conform with Delhi Master Plan 2021 and other requirements or close after last year's fire.

Tech-savvy 'handlers' manage exam chaos from paper leak to student training

Delhi: Port cargo, the police dog squad, political campaigns, and even spy rings are no longer the only jobs for a "handler". The NEET-UG paper leak conspiracy investigators know how "handlers" function in the shadowy nationwide test business based in Bihar and Jharkhand. "The nine handlers arrested in the NEET-UG case so far - six in Jharkhand and three in Bihar are tech-savvy individuals who played a crucial role in orchestrating the leak of question papers, training examinees who paid for these to memorise the answers, and even escorting them to their respective centres," a top cop said. The six suspects from Jharkhand's Deoghar lived in rented housing as laborers. The task was to provide leaked papers while retaining secrecy and identity. "Once a particular exam got over, they would get to work on identifying the chinks in the system for the next one," he claimed. These handlers sought pretextual connections with coaching centers, schools, and colleges to grow their clientele. They sought out exam officials to bribe for useful information. On the morning of the NEET-UG exam, Bihar Police raided a safe house on a tip-off



handlers herding roughly 30 applicants into Ram Krishna Nagar on Patna's outskirts. "Examinees memorized leaked question papers all night. Personal automobiles were used to bring them to their exam centers, with all necessary safety precautions "Officer noted. Around 2010, online entrance exam form submission replaced mail-in applications nationwide. Fraudsters and dishonest authorities exploited old system weaknesses."Before online forms, exam centers assigned roll numbers based on application envelope receipt. A Bihar-based IPS officer said criminals sent many application forms in one envelope using codes like 'bogie' and 'engine' to allude to candidates and their proxies. "This strategy ensured that all these candidates were allocated roll numbers for the same examination centre and found evidence of these and hall, facilitating cheating.

29 squares of the city are under the surveillance of CCTV cameras

comings. The Deputy Commissioner saw the function of various components involved in this project on the video wall installed in the ICCC Centre. He showed great interest in watching the live video of how the cameras and traffic lights installed at the squares and intersections are working. ICCC Chief Manager Gaurav Tiwari gave information about each component to the Deputy Commissioner. He told that this project is one of the important projects of Smart City, which is related to the city's

traffic system and its control. This project has 6 field components. These include VMD. That is, there are

36 variable message display boards, which 31 have been installed so far and 27 have been made operational.

He said that CCTV installation has been done at 29 squares and intersections, while public address system has been installed at 128 junctions. Similarly, emergency call boxes have been installed at 32 out of 35 places and 2 environmental centers have been set up. Apart from this, automatic traffic control system has been completed at 28 places. 2 ATCS intersections, including Sector-12 Tpoint and Shaheed Madan Lal Dhingra Chowk, have been made live.



European Space Agency shares high-resolution 'Ram Setu' image

Between Rameswaram Island on India's southeast coast and Mannar Island on Sri Lanka's northwest coast, the Ram Setu runs 48 kilome-

ters. The Ram Setu, Adam's Bridge, a network shoals connecting India and Sri Lanka, was recently p h o tographed by the European



Space Agency in great detail. Copernicus Sentinel-2 satellites captured the image. Satellites with an innovative wide-swath high-resolution multispectral imager with 13 spectral bands offer a unique view of land and vegetation. Between Rameswaram Island on India's southeast coast and Mannar Island on Sri Lanka's northwest coast, the Ram Setu runs 48 kilometers. It divides the Indian Ocean's Gulf of Mannar from the Bay of Bengal's Palk Strait. One bridge end is on Mannar Island.

The 130-square-kilometer island is connected to mainland Sri Lanka by a road and railway bridge at its southern end. Pamban Island (Rameswaram Island) is the bridge's other end. The 2-km Pamban Bridge connects India to the island. Pamban on the western tip and Rameswaram 10 kilometers east are the island's principal settle-

Delhi: External affairs minister S Jaishankar said that the ministry is working with state and Union territory police forces to speed up passport applicant police verification to strengthen passport delivery ecosystem. On Passport Seva Divas, Jaishankar said his ministry is committed to ensuring that passports facilitate international trade and investment and improve worldwide mobility to boost the country's growth. The government opened 440 Post Office Passport Seva Kendras to improve passport services. This complements the 93 Passport Seva Kendras, 533 passport processing centers, and 37 regional passport offices nationwide.



The ministry integrated passport issuance systems in 187 Indian missions abroad. Jaishankar said the police verification time to facilitate passport delivery. He added that 9,000 police stations in 25 states and Union territories have implemented "mPassport Police App,'

which streamlines police verification. The government will purchase 156 light combat helicopters from HAL for 50k-cr

Delhi: The defence ministry has let Bengalurubased Hindustan Aeronautics Limited (HAL) bid for 156 Prachand light combat helicopters (LCH) to strengthen the Indian Army and Air Force, officials said. According to anonymous authorities, the estimated cost of the new helicopters, 90 for the army and 66 for the IAF, is 50,000 crore. This will increase India's self-reliance. Two months earlier, the ministry let HAL bid for 97 light combat aircraft (LCA Mk-1A) to help the IAF overcome a fighter squadrons shortage. The new fighter planes will cost 67,000 crore approximately. HAL has produced 15 limited series Prachand helicopters for the IAF (10) and army (5), and soon series production will commence. Officials stated HAL will fulfill the 156 helicopter order in five to six years after signing the contract. The series production LCH will have more than 55% indigenous content, up from 45%. The LCH can demolish enemy air defenses, target slow-moving and remotely piloted aircraft, destroy high-altitude bunkers, conduct counter-insurgency operations in jungle and urban areas, and support ground forces. The government's affirmative indigenisation lists limit the import of weapons, equipment, and ammunition. for five years to promote defence self-reliance,

including these helicopters. The defence ministry banned 98 weapons and systems, including futuristic infantry combat vehicles, ship-borne unmanned aerial systems, mediumrange precision kill systems, ammunition, radars, sensors, and fighter jet, maritime surveillance plane, warship, helicopter, and tank equipment, last year.
