'Pablo Escobar', 'maniac': CM Naidu's all-out attack on Jagan Mohan



NEW DELHI: Andhra Pradesh chief minister Chandrababu Naidu on Thursday unleashed a no-holds barred attack on his predecessor YSR Congress leader Jagan Mohan Reddy comparing the former chief minister to Colombian drug lord Pablo Escobar as he alleged drug menace in the state in the last five years under the YSR Congress rule. Naidu also called Jagan Mohan Reddy a maniac who aspired to become richer than Tata, Reliance and Ambani.

Releasing a white paper on law and order and ganja (marijuana) prevalence, Naidu claimed that he never saw such a situation like how it was when Reddy ruled. "Only one person can be compared to what happened in Andhra, and it is Pablo Escobar," he said in assembly, in an apparent reference to the drug menace. The CM alleged that the southern state had emerged as ganja capital between 2019 and 2024 and vowed to crack down on it.

"Pablo Escobar is a Colombian drug lord, he is a Narco terrorist. He turned politician and then started his cartel to sell drugs. He earned \$30 billion at that time, now it's \$90 billion worth. He was arrested in 1976 and in 1980 he became the number one richest drug lord in the world. One can become richer by selling drugs as well. What was the aim of former Chief Minister (YS Jagan)? Tata, Reliance, Ambani have money and he aspired to become richer than them. Few have needs, few have greed and few have mania and these maniacs do these kinds of things," Naidu said in the state assembly.

He was released on Thursday in accordance with the ruling. After adopting the state government's request for Karwariya's premature release, the governor issued an order to release him under the authority granted on her by Article 161 of the Constitution.

Article 161 authorizes the governor to award pardons, reprieves, respites, or remissions of penalty, as well as to suspend, remit, or commute the sentence of any convict under any law relating to a matter within the scope of the state's executive power.



City witnessing huge shortage of doctors at Govt hospitals

Over 25% posts of doctors vacant

Prayagraj: Key Sangam city-based government hospitals are reeling under an acute shortage of doctors. A status check reveals that seven of these hospitals that shoulder the bulk of patient load are badly hit by the shortage with 90 posts of doctors against the sanctioned strength of 356 presently lying vacant (25% of total posts).

With Mahakumbh-2025 round the corner, during which time temporary hospitals would be set up in the mela area, the shortage of doctors in the main hospitals of the city - which would also act as main referral hospitals - is cause for worry, district officials conceded. They believe that the shortage of doctors needs to be addressed on a priority.

If hospital officials are to be believed, except for the TB hospital in the city, which has a sanctioned strength of eight doctors, all other government hospitals are functioning with less than sanctioned strength of doctors. More than 50% of posts are vacant in Moti Lal Nehru (Colvin) Divisional Hospital alone which has sanctioned posts of 36 doctors and 18 of these posts, including posts of four medical emer-

gency officers, are lying vacant. Likewise, over 15% of posts at the busy SRN Hospital of MLN Medical College, too, are lying vacant. It has 181 sanctioned posts out of which around 20 are lying vacant. At the same time, against the sanctioned strength of 41 doctors in Tej Bahadur Sapru (Beli) Hospital, 10 posts are vacant. There are 40 posts of doctors in Dufferin Hospital, but here too a mere 29 doctors are working. Even in Government Unani Hospital, 12 posts of doctors are lying vacant out of the total 40 posts. Officials of most of these hospitals claim that the process of getting the doctors is well underway. Even Dr Vatsala Mishra, acting principal of Motilal Nehru Medical College, under which the SRN Hospital functions, said that the process of appointment for vacant posts of doctors is on. Some doctors will also come on transfer.

Renewable energy has demonstrated positive growth

This year hit many records with unprecedented weather conditions, from extreme winters to heatwaves and torrential rains. Rising heatrelated illnesses and deaths in India and across Asia, Europe and North America this summer have laid bare the inescapable impacts of climate change. The heatwave in India, with maximum temperatures crossing 50°C, sent power demand soaring, with peak demand touching 250 gigawatts in May 2024, an increase of 3 per cent from the peak demand across all months in financial year 2023-24 (243 GW), putting pressure on the electricity system. With government efforts to ramp up electricity generation by increasing domestic coal supply and availability of imported coal and gas, peak demand increased by 4 per cent during the same period. Such climate change-induced extreme weather events not only have an impact on electricity demand but also other macroeconomic factors like inflation and high interest rates, crippling the economic growth of a country. The Reserve Bank of India (RBI) governor Shaktikanta Das reiterated concerns about the risks posed by global warming and how frequent climate shocks drive up food prices. Addressing climate change is, therefore, a top priority for the government. India has pledged to install 500 gigawatts of renewable energy capacity, produce 5 million tonnes of green hydrogen a year, reach 30 per cent electric vehicle (EV) sales and cut CO2 emissions by one billion tonnes through greater energy efficiency, all by 2030. Later this month, when Finance Minister Nirmala Sitharaman presents her sixth full Budget in the Lok Sabha, Prime Minister Narendra Modi's government can take decisive action to honour its pledges. Last month's announcement of Rs 7,453 crore (\$892 million) in Viability Gap Funding for two largescale offshore wind projects-India's firsttotalling 1GW was a significant, albeit overdue, step toward the 2030 target. The government should extend such funding to micro, small and medium enterprises (MSMEs) so they can partner with multinational investors to develop a supply chain of locally manufactured components and skills. While renewable energy has demonstrated positive growth, it has fallen short of the 2030 target. Successful deployment and integration of renewable energy depends on a secured supply chain, smart grid infrastructure expansion, flexible generation sources and development of innovative market mechanisms. As such, the renewable energy ecosystem requires budgetary suppo rt, tax breaks, relief in import duties and tariff barriers or tax credits to expedite development and attract necessary investment. Despite increased investment and deployment of clean energy, India lags behind other nations in research and development (R&D) spending. India ranks fourth in the world in renewable energy capacity. Yet, its R&D expenditure is well below the annual average spent by member states of the International Energy Agency (IEA), which is about Rs 986 crore (\$118 million), based on the most complete data available from 2022. Last year, India's Ministry of New and Renewable Energy said it had allocated Rs 228 crore (\$27.3 million) for R&D over five years from FY 2021 to 2026, which adds up to about Rs 46 crore (\$5.5 million) a year. The Institute for Energy Economics and Financial Analysis calculated that the total government spending on renewable energy R&D in FY 2021-22 was about Rs 124 crore (\$15 million) across all sectors, including the national wind, solar and bioenergy institutes and other programmes. Last year, the government more than doubled that figure with its National Green Hydrogen Initiative (which has an R&D budget of Rs 400 crore or \$48 million). While laudable.

Congress wants to bring its old Dalit vote bank

But after the results came out and the victory of Azad Samaj Party (Kanshiram) chief Chandrashekhar Azad in the very first attempt, it is being said about the Dalit voters that they are slipping out of Mayawati's hands. Due to this, now all the parties are mainly eyeing the Dalit votes. Actually, Mayawati, who never contested by-elections from Uttar Pradesh, is contesting by-elections this time, because she is also worried that her Dalit and Mahadalit vote bank may be snatched away by Congress and SP. On the other hand, Azad Samaj Party will also become a challenge for her now, because the attention of Dalits is suddenly being towards Chandrashekhar Azad and so is that of the backward classes. BSP has not been able to win even a single Lok Sabha seat in this Lok Sabha election. Worried about this, Mayawati is now engaged in putting BSP workers to work again and is also working on a strategy to strengthen her party cadre by going from village to village, which clearly shows that BSP, which never claimed to contest by-elections, is now forced to contest byelections this time so that Dalits who are moving away from it do not break their ties with it forever. She is not doing this only in UP, but is doing this in many other states including

Haryana, so that she keeps

getting the support of Dalit



vote bank and keeps winning some seats to save her reputation in future. However, while Mayawati is there, it is a far-fetched idea to separate 100% Dalits from her, rather no other party can bring the Dalit voters who go to BSP's account to their side at the present time, no matter which party it is, and some political experts believe that 50% of the total Dalit voters of UP still like Mayawati.

Anyway, this time along with Congress, SP chief Akhilesh Yadav is also pushing his backward, Dalit and minority i.e. PDA formula and a new political player Chandrashekhar Azad is also making a mark Dalit politics. Chandrashekhar Azad's Azad Samaj Party is also preparing to contest all 10 seats of the by-election. That is, now the next biggest political battle will be seen in the 2027 assembly elections of Uttar Pradesh for the votes of Dalits and a multi-cornered struggle to take Dalits with conferences before this Lok

them. But one thing is that whoever the Dalits go with, he will sit on the throne of Lucknow in 2027.

They will try their best to bring them to their side. This time also a good number of Dalits have voted for the All India Alliance i.e. Congress and Samajwadi

Congress wants to bring its old Dalit vote bank with it somehow, for which it is keeping an eye on Dalit voters and wants that the way Dalits remained with it for about four decades after independence, they should return to its side again. On the other hand, the ruling party BJP has also been seen surrounding the Dalits for a long time and a large number of Dalit voters had also joined the BJP. But this time, due to the issue of ending reservation and changing the Constitution, a large number of Dalits have parted ways with the BJP. However, to woo Dalit voters, BJP had also organized a large number of Dalit Sabha election. But its game was spoiled by its big-mouthed leaders and all the hard work went to waste. In the midst of all these political players, every party is trying to save its branch in the by-elections to be held on 10 seats in Uttar Pradesh this time, so that the path to victory in the future can be opened or chances of more victory can be seen. In fact, if BJP loses the by-elections on these 10 seats, it will mean that its defeat in the 2027 assembly elections is also certain and BJP does not want this under any circumstances.

NPS-Lite can streamline welfare funds & pension schemes for the poor—with 2 key reforms

It could choose a reliable pension fund to manage the contributions so that the informal sector workers are able to enjoy the same level of transparency and regulatory scrutiny of their investment as the formal sector workers. If a worker moves to another state, the pension account stays with her. This is a better strategy than starting a new scheme with a separate fund for each state. The Ministry of Finance and the PFRDA need to create an enabling framework that reduces friction for a state government to plug into

the NPS ecosystem. On the other hand, the Ministry of Labour and Employment needs to use the existing NPS infrastructure instead of starting separate welfare funds. The distinguishing feature of a pension scheme from any other savings product is the periodic payment (also known as an annuity) that a pensioner receives from retirement to death. Without this, the corpus in a pension account is not too different from the corpus in a savings account. The current NPS framework requires a member to purchase an annu-

provider at the time of retirement. The member has to use at least 40 per cent of the accumulated surplus to purchase an annuity plan, which continues to pay a specified amount until death. The problem with annuities is that while everyone pays the same premium at retirement, only those who live longer benefit from the payment. Essentially, those who live longer get subsidised by those who die early. This becomes an important issue in the case of informal sector workers, whose life expectancy

ity from a licensed service is likely to be lower than those in the formal sector. We don't want a situation where the poor are subsidising the rich. The PFRDA needs to invest in infrastructure that can price annuities

for NPS-Lite customers more accurately. It can build life tables that reflect the appropriate mortality scenario for the informal sector. This may require a tie-up with the birth and death registration system. Another approach is to allow phased withdrawals from the pension account based on specific formulae.

Xi must address key challenges first

Central Committee of the Chinese Communist Party is finally underway in Beijing. The session, taking place from 15-18 July, has 205 full members and 171 alternate members in attendance. It aims to address China's economic problems and boost the country's modernisation drive. Held once every five years, the plenum serves as a crucial platform for announcing key economic directives and reforms that attract global attention. And it assumes heightened importance against the backdrop of several challenges. These include a downturn in the real estate sector, ongoing efforts for post Covid-19 recovery, and a notable slowdown in China's second-quarter GDP growth rate of 4.7 per cent. Additionally, amid US-China trade tensions and American restrictions on technology transfers, it shows that Beijing is strategically pivoting toward greater economic self-sufficiency. In this session, President Xi Jinping, also the General Secretary of the Central Committee, delivered a work report on behalf of the Political Bureau, outlining priorities for 'comprehensively deepening reform and advancing Chinese modernisation.' Central to these policy directives are initiatives to bolster advanced manufacturing, overhaul the tax system to mitigate debt risks, navigate a substantial property market crisis, stimulate domestic consumption, and breathe new life into the private sector. State-owned media is actively supporting Xi's leadership, portraying him as guiding China through profound social and economic transformations via comprehensive reforms. The People's Daily emphasised that "the path of Chinese-style modernisation has evolved from reform to the comprehensive deepening of reform, mark-

ing a critical juncture." In strikingly

The overwhelmingly positive tone of the plenum and Xi's leadership portray a narrative that, despite challenges, comrades should trust in his vision and leadership. It suggests that, drawing from the president's past successes in reform and opening up, he is positioned to guide the country toward even greater prosperity. Efforts are also being made to highlight how policy guidelines are capturing the attention of foreign media and investors, and to counter assertions that global leaders and businesses now perceive Beijing unfavourably. A commentary highlighted recent visits to China by Hungarian Prime Minister Viktor Orban, Bangladeshi Prime Minister Sheikh Hasina, Vanuatu Prime Minister Charlot Salwai, and Solomon Islands Prime Minister Jeremiah Manel. These visits taking place around the plenum, the commentary read, is evidence that these countries consider China an important [economic] partner. Chinese scholars and economists present a nuanced perspective on the current situation.

According to Minister Atishi, "Many issues of financial mismanagement have come to the fore in these colleges in the last few years, but the Kejriwal govt has decided that the teachers and students at those colleges should not suffer due to the mistakes of the management and administration." She stated: "Keeping in mind the welfare of teachers, their medical benefits and pension benefits which were struck due to financial mismanagement, Delhi govt is releasing a fund of Rs 100 crore in the second quarter for these 12 colleges." The minister went on, saying, "Kerry's government concentrated on higher education in addition to schools, opening three new universities and expanding existing ones. Delhi's higher education system is significantly influenced by the 12 Delhi University colleges that receive full government funding." The minister has authorized the release of the second quarter installment, according to the government. Additionally, the Kejriwal government has budgeted roughly Rs 400 crore for these financed universities in 2024-2025, according to a release. Delhi Skills University "revokes" EWS, SC/ST fee concession; no clearance in place

Centre advises CBSE on biannual board logistics

Delhi: Officials said the Union ministry of education has ordered the CBSE to create a plan for twice-yearly board exams and will confer with stakeholders next

Ghaziabad Residents Drink Nearly Rs 400 Crore in Beer During Heatwave Delhi: The excise agency reports that Ghaziabad

residents have consumed approximately Rs 400 crore in beer due to the past three months' scorching. Officials credit high heat and consistent prices for this record sales result. People in Ghaziabad and the National Capital Region sought ways to cool themselves due to extreme heat. In addition to lemonade, lassi, and buttermilk, many Ghaziabad inhabitants chose alcoholic beverages, especially beer, which generated large excise money. Ghaziabad beer drinkers spent Rs 397.16 crore during April to June 2024, up 106% from the previous year. Even more, beer can sales rose 116%. Over 13.3 million cans were sold this year, up from 11.5 million last year. Beer helps many cope with soaring temperatures. Due to this tendency, the excise department saw significant income growth throughout these three months. District excise inspector Rakesh Kumar said the severe heat and stable beer pricing drove record sales. said, "The data clearly shows that the intense heat and no price hike were the primary reasons for the exceptional revenue of Rs 397 crore." Beer sales during the heatwave generated significant excise department money, showing how extreme weather can affect consumer behaviour and local economies.
