Tried to 'save' those ...': PM rakes up Godhra train arson to accuse oppositon of appeasement

NEW DELHI: Prime Narendra Minister Modi on Saturday brought up the 2002 Godhra train arson incident and accused RJD president Lalu Prasad of attempting to protect those responsible for the death of over 60 kar sevaks during the tenure of UPA chairperson Sonia Gandhi.

While addressing a rally at Darbhanga in Bihar, PM Modi attributed this to the opposition parties' practice of "appeasement politics".

"It is because of this appeasement politics that the father of Bihar's 'shehzada' (allusion to Tejashwi Yadav) had tried to save those who were responsible for the Godhra train burning incident", said Modi, adding "after all, it was the rule of Sonia madam", referring to the UPA chairperson who was also the president of the ruling Congress.

Modi further alleged that Lalu Prasad, who was the Railway minister at the time and has



since been convicted in fodder scam cases, set up an inquiry committee that produced a report exonerating the perpetrators of the crime.

"He (Lalu Prasad), who has himself been convicted (in fodder scam cases), was then the Railway minister. He set up an inquiry committee and got a report made which exonerated those guilty of the horrendous crime. But the court threw the report away", PM Modi said. The Prime Minister also

Jaishankar on Nijjar plot: Canada blames us, but shows no evidence

NEW DELHI: Foreign minister S Jaishankar said on Saturday that Canada never provides any evidence but blames India for crimes committed there, while a Canadian govt report — "Public Inquiry into Foreign Interference in Federal Electoral Processes and Democratic Institutions" claimed Indian officials and proxies engage in a range of activities to influence Canadian communities and politicians, and that "India directed foreign interference activities" during the 2019 and 2021 general elections in Canada. Jaishankar's remarks come after Canadian police said they were looking at possible Indian links following the arrests of three Indian nationals for the killing of pro-Khalistan separatist Hardeep Singh Nijjar, designated a terrorist by India. Canada has "allowed organised crime, specifically from Punjab, to operate from there", the foreign minister said at a press conference in Bhubaneswar. "I just saw before coming in that three people have been arrested. They apparently are Indians with some kind of a gang background. We will wait for the police to tell us more. But normally, if you don't have a political agenda, if I say I suspect you, I will produce the proof," he said at a press conference. "We have never been given anything by Canada which involves the govt of India. In fact, we have repeatedly told you (the Canadian govt), if you have something, please give it to us," Jaishankar added.The Canadian report by commissioner Marie-Josée Hogue refers to Indian officials, including Canada-based proxies, engaging to influence Canadian communities and politicians.

Prayagraj: Guria village located on GT Road between Varanasi and Allahabad has a story you might want to hear. Although, farming and carpet weaving are the main occupations of the villagers, the little dusty village Guria is hitting headlines for 'Project Mala', a program run for the elimination of child labour from the hand-knotted carpet industry, by providing education, mid-day meals and healthcare facilities for children in this carpet weaving belt. family names. Both measures help them stay free of class, caste, societal, and sartorial pressures when in school

Villagers here are happy to get an opportunity to educate their children. The school receives 500 applications for every 10 seats; however, the number of boy applicants exceeds girls. A couple of years ago, it was decided to open a nursery school for younger children. Once the notice went out, 300 boys lined up outside the school for admission and not a single girl child. The school then decided to make

cycles are provided to students Standard VIII onwards to stem the dropout rate. The school has also created a girls' hostel. Slowly, some

families are coming around. However, the battle to keep girls in school is as hard as ever. Parents want to get them married post middle school. Also, once girls reach puberty, parents are reluctant to send them fearing their safety, especially if they are from surrounding villages and have to walk quite a bit.

Rani (name changed) was 8-years-old when her father, a local weaver, allowed her to pursue her

education. 8 years later, she cleared her class 10th Exam, only to have her dreams of being a journalist crushed! She was pulled out of school so that she could get married. In anger and disappointment, she eloped, but was brought back and forcibly married to a young man in the village, who is illiterate. She is almost 19 now with little hope of ever making it on her own. A beginning, a dream, an ambition... a step towards the future with minor spelling hiccups.

The school generates earnings for local carpenters who make and maintain the school furniture. They mostly work in one part of the schoolyard. Local tailors are also hired to make school uniforms. They have a small workspace within the school.

The erratic electricity supply discourages none. Everyone turns up as per schedule. Local teachers are hired as staff and then trained under Project Mala volunteers to hone their teaching skills and to be sensitive to the children's development needs. It is heartening to see how aware both boys are girls here are. Most of the girls want to become teachers and doctors, while the boys, engi-

neers. Very recently, another bright student, when she passed out of school, her parents wanted her to get married. She came to the school for help, and the teachers intervened. Today, she is pursuing a degree in the Sciences stream in Allahabad.

Despite the odds, it is worth a mention that even the remotest of villages in the Allahabad district is undergoing a wave of change. From extreme poverty to opportunities like this, most children now have aspirations of a career so that they are self-reliant and can look after their families.

Fungal, bacterial skin allergy cases up

Prayagraj: With summer season at its peak, skin allergies including photo-dermatitis and fungal infections have started troubling city residents. Dermatologists in city hospitals say while there has been a jump of 10-15 times in photo-dermatitis cases, the number of fungal infection cases too has increased by about 10 times in the hospitals. Experts say whereas photo-dermatitis is caused due to prolonged exposure to ultra-violet rays of the sun, fungal allergies are caused by sweating in the hot weather.

"Since summer has already begun, there has been an increase in the number of patients seeking consultation for skin allergies at our clinic. Nearly, half a dozen patients come to our clinic on a daily basis, out of which several cases are that of photo-dermatitis (the number on routine days in other seasons is usually one or two only), whereas the number of fungal infection cases has risen to 10-12 a day against 0-2 cases on routine days in other seasons. In the case of fungal allergy, there is an itchy disorder due to sweat. It mostly is witnessed in the foot, groins and arms area, whereas photo-dermatitis is because of exposure of the face and outer area of forearms to direct sunlight. In this infection, the affected area becomes reddish and later turns white," says skin specialist Dr. Naveen Kumar Yadav.

Other doctors echoed his views and claimed that though skin infections are prevalent in all age groups, it is more common in the extreme age groups, like children and the elderly, while skin allergies have mostly been reported in the young and middle-age groups. The extreme age group people cannot bear the allergies, so they are less prone to it, but as their immunity is less, they are easy prey to infections. The young and middleage groups are more prone to allergic reactions because of increased exposure to sunlight.

when the mercury is hovering above 43 degree Cel- heat stroke, skin related alisius mark, the chances of heat stroke have gone up manifold. A person can fall severely ill in such extreme weather conditions. It is therefore, necessary to take extra care during summer season to avoid falling prey to heat stroke. Experts say that the people who travel in sun mainly due to office work are likelihood of falling ill. Thus, they should take extra care of themselves. The water intake in such a weather should increase and one should drink not habitual to hot humid

water each day. Apart from ments like skin burn, rashes etc also take place during the time when the mercury is staying above 43 degrees mark.

People should wear dresses that cover their body parts including hands, neck and face to avoid sun burn or skin related ailments. Heat stroke, also known as heat hyperpyreixia, occurs due to overheating of the body during summers. This may also occur in people who are

> According to experts, certain people, who lack sweat glands, are more prone to heat stroke. While, unsuitable clothing and poor eating and living conditions always increase the risk. People who are exposed to sun for longer period and lack sweating, may develop body temperature as high as 105 degree Fahrenheit, which is also known as summer-fever. Due to abnormal rise of body temperature, the central nervous system and brain may get commonly. The people

can faint even. Thus, there is a dire need in such a season to drink lots of water.

The recent records of the Outpatient Department (OPD) of the district hospitals show that there is a sudden spurt in the number of patients coming for treatment of heat-related diseases, including heat stroke. According to the doctors, around 30% increase in patients with heat related diseases has been reported in the past one week when mercury had crossed 40 degree Celsius mark.

Librarian posts vacant in govt colleges for over a decade

Prayagraj: At a time when the state government is taking initiatives to improve the quality of teaching in higher education institutions, over 300 librarian positions have been lying vacant in government and government-aided degree and postgraduate colleges for over a decade.

In the absence of regular librarians, the duties are performed by either teachimpacted are the state's 321

UGC from January 1, 1986, and college administrations are not permitted to make appointments to jobs receiving UGC pay scales. As a result, on May 13, 2009, the state government prohibited the appointments of librarians at the level of managers at these colleges," informed the principal of a government-aided degree college.

Following that, the duty for appointing librarians at government-aided degree colleges was delegated to the Prayagraj-based Uttar Pradesh Higher Education Services Commission (UPHESC) at a state cabinet meeting in November 2012 "However, the Directorate of Higher Education has not requested requisition of empty librarian positions

from institutions since then, nor has the recruitment process kicked off," the principal claimed. Even state higher education department officials admit that, in addition to the 200 or so librarian positions that are empty at government-run degree schools, more than 100 librarian positions are vacant in 170 government degree colleges located around the state.

"At the moment, librarians work in just 36 of the 170 government-run degree colleges in Uttar Pradesh. Even librarian positions have not been created in almost two dozen colleges, and more than 110 colleges do not have regular librarians. The appointments in these cases would be made through the Uttar Pradesh Public Service Commission

(UPPSC). However, after 2005 and 2008, the commission did not issue any advertising for the recruitment of librarians in these institutions," the authorities explained.

Secretary of UPHESC stated that the recruitment process could not begin due to non-receipt of requisition regarding vacant posts of librarians from the UP Directorate of Higher Education.

Suresh Kumar Tripathi, former MLC stated, "On the one hand, we have competent librarians looking for jobs in UP, while on the other hand, we have institutions starving for librarians to run their libraries professionally. I request the state administration to quickly hire librarians to fill all vacant positions.'

Growing clamour for green space with residences

Prayagraj: The growing clamour for green space within their residences is rapidly catching up among residents. The idea for developing green space within the house is to seek comfort and relief from scorching summer heat which makes life deplorable for citizens during power cuts. However, people adopting gardening as a hobby during summer season need to learn some basic rules, which will go a long way in keeping their green space alive.

"Over watering the plants or the lawn during summer is the most common mistake that people commit, as far as longevity of the plants is concerned. Each plant has different needs; one should water plants sensibly and in the evenings, so that it keeps the plants moist overnight. Classifying the plants is one of the elementary factors, if the plants are arranged according to the amount of sunlight they need, things can be lot easier for the caretaker of the garden" said Kailash Sharma.

Indoor plants, half shade plants and full shade plants are the three major classifications for household plantation. Half shade and full shade are two types of plants which need sunlight for their survival, although the difference between them is that half shade plants need only a definite amount of shade, and full shade may need an enclosure where only nominal amount of sunlight enters. "One should keep full shade plants inside a net shade in summer and should move half shade plants to the shaded parts of the garden, as summer heat may pose danger to them and over exposure to the sun may even destroy them. Organic manure is also the key to keep moisture stored for a long time," he explained. Another nursery owner said "Watering should be done only when the sun's heat is not at its peak, that is before 9 am, or when it is fading that would be after 5 pm. One should completely avoid cutting plants or shaping them during the summer. As far as lawn cutting is concerned it should be done in the evening and the lawns should be watered immediately after it's mowed." He further added "chemical fertilizers are a complete no-no during summers and only old animal manure should be used during this season. Also, one should clean the lawn thoroughly after it's mowed, as the leftovers of the lawn may kill the living grass. "

Salaried class beware: First week of every month lucrative for looters

PRAYAGRAJ: There is no doubt that the first week of the month has a big attraction for highway robbers on bikes. This is the time when people collect arrears or go to banks to get their pension money or withdraw money for monthly expenses. Employers also go to banks to withdraw salary funds for their staff. In short, bank transactions of the recurring nature are at their peak in the first week of every month. That could explain why roadside snatchings are so common round this time of the month. It would seem that the robbers keep an eye on who all are visiting a bank. They have an intricate grass root network of informers, who provides tip off, when a man moves out of the bank, with the presumption that he has withdrawn money. On mobile phones the crooks can inform each other about it and plan their move.

Several cases have occurred in the first week of last month when women reporting cases where a man zoomed past on a motorbike, hit them and snatched their purses, an officer said. He called it a "terrorising" crime for women. That sense of panic has been quelled to some extent, with habitual offenders wary of an arrest owing to the spate of arrests. However, a desperate citizen called up on phone and said: 'If all road crimes are being committed by criminals on bike, and if cops cannot catch them, should they not be put off the roads at least during the first week of every month? He says, 'Can't the Government put a limit on the speed of the bikes at the manufacturing stage itself, fixing the limit at 40kmh?'

How Biden's xenophobia, low-growth charges fall flat on India

President George W Bush was famous for his quite often hilarious gaffes, but he has been receiving steady competition from the 81-year-old President Joe Biden. The latest Biden pronouncement may be more by way of a clumsy and ill-informed analogy gone wrong. Luckily for him, his presidential election rival, the almost 78-year-old Donald Trump, makes quite a few bloopers too.

Republican contender, former President Donald Trump, may be tough on Mexican immigrants with his infamous, if not too effective, border fence and wall, but Democrat Joe Biden, the incumbent president, is in harmony with the Democratic Party pro-immigration stance. This even in the face of internal advice that he should tough talk on the same border issue Of course, hordes of poor and largely illiterate illegal immigrants in 2024 who don't speak English are not as welcome as they were in the 1870s. In the 19th century and before, immigrants, largely from Europe, slaves brought in from Africa, and some immigration from China, helped to populate the vast country. They threw out the British colonists, pushed back the French and Mexicans, subdued the native Red Indians, built the engines of growth, and even fought a civil war amongst themselves. Immigrants, many originally poor and persecuted in their erstwhile home countries, have been a crucial feature of American DNA. This is what Biden meant, but perhaps he should have stopped right there. Immigrants into America are known and lauded for their hard work, ingenuity, and grit, and Biden was addressing a crowd of mostly Asian Americans. More recently, the brilliant IIT educated ones from India, its 'brain drain' and America's gain, have been most useful in building America's preeminence in IT, other technology, and commerce. Scores of Indian-origin CEOs of marquee companies on the Nasdag and S&P 100 indices have led to the joke that you can't be CEO in America if you aren't Indian. It is a complete makeover of the earlier American image of India as a land of teeming poverty, with tigers, snake charmers, and fakirs thrown in. President Joe Biden, keen to distinguish his candidature from that of Donald Trump, decided to praise immigrants at a campaign reception fundraiser. On the campaign trail for Biden 1.0, he had vowed to enact legislation to make the immigration process more 'humane' in contrast to President Trump's mostly intended, but not implemented, harsh measures. This time, too, Trump is speaking of deportations.

However, as president, Biden could not make much progress on immigration legislation without bipartisan support because of surges of illegal immigration at the southern border. And calls, certainly from Republicans, but even from Democrats, to seal the border and crack down on asylum seekers. Some went so far as to call for banning asylum altogether. But the consensus is that, at this fundraiser, Biden let his analogies run away with him. Biden said American allies and partners Japan and India are struggling economically 'because they're xenophobic'. He included 'frenemy' China and combatant Russia in the illustration as well. Japan is opening up to a cautious immigration policy as it grapples with its diminishing and ageing population, and its economy has been showing signs of recovery from a 25-yearlong recession. It is keen, however, not to import terrorism and other social upheavals into its very well-ordered culture. India is the most populous country in the world, with 65 per cent of its people under the age of 35. It is the fastest-growing major economy in the world, with 6-7 per cent GDP growth per annum, and harbours, willy-nilly, nearly 50 million illegal immigrants, main-ly from Bangladesh and Myanmar. These immigrants have not been rounded up and deported in the main.

In late 2023, China created a new 31.5 million-barrel strategic oil storage facility at the eastern Chinese port of Dongying. The heavy purchases of Russian crude oil have found their place there. Is it hedging for a future oil price surge or building stocks for a future conflict is being speculated. China currently holds roughly 511 million barrels of Strategic Petroleum Reserve (SPR), which corresponds to less than 50 days of Chinese petroleum imports.

Petroleum products continue to be strategic assets that are still the drivers of all transportation, significant electricity production, and many industrial processes. Petroleum and gas reserves are nature's blessing to only a few select regions of the world. Most large economies in Europe, China, Japan, and India, among others, are major importers of petroleum products.Global strategic petroleum reserves refer to crude oil inventories (or stockpiles) held by the government of a particular country, as well as private industry, to safeguard the economy and help maintain national security during an energy crisis. Strategic reserves are intended to be used to cover short-term supply disruptions.

In 2022, approximately 4.1 billion barrels of oil were held in strategic reserves by IEA member states, of which 1.4 billion were governmentcontrolled and the remainder were held by private industry. The US, China (non-IEA member), and Japan are leading crude oil consumers and maintain the largest SPR. Many other non-IEA countries have started working on their own SPR.

China's Strategic Petroleum Reserves

China has the second largest storage, at 511 million barrels. China's daily consumption is around 12 million barrels of crude. Thus, their SPR is equivalent to between 40 and 50 days of imports. China eventually wants to raise the figure to 90 days of reserve. Russia has been the major supplier to China of late, contributing as much as 2.14 million barrels per day, overtaking Saudi Arabia. Russian oil was substantially discounted due to Western sanctions. Stockpiling partly insulates Beijing from the supply chain and pricing

dynamics. Also, larger stocks will be required for a possible Taiwan Strait conflict that could result in a military blockade or economic or trade sanctions. China has also secured supply chains through pipelines from Russia, the trans-Myanmar oil and gas pipeline, and from central Asia, predominantly Turkmenistan.

Simultaneously, China is rapidly shifting to electric vehicles and is not only building lithium stocks for batteries but has also acquired processing facilities and mines, including overseas. Investment bank UBS estimates that China might control a third of all global lithium supplies by 2025. The US SPR is the world's largest, with an authorised maximum capacity of 727 million barrels. The reserves are kept in salt caverns located at different locations along the Texas and Louisiana Gulf Coasts. The US consumed an average of about 20.01 million barrels of petroleum per day. It was a net petroleum exporter of 1.64 million barrels per day in 2023. It thus has the capacity to play around with the SPR. The US government has historically tapped into its SPR following man-made accidents, economic crises, and natural disasters, though it has also sold and loaned crude oil from the SPR to other nations at times.

Delhi: According to persons acquainted with the situation, Indian grocery chain Vishal Mega Mart Pvt has chosen banks as it moves forward with a planned IPO in Mumbai this year. These individuals, who wished to remain anonymous due to the confidentiality of the discussions, stated that Vishal Mega Mart selected Kotak Mahindra Bank Ltd and ICICI Bank Ltd to assist in setting up a share sale as early as the fourth quarter of this year. According to the persons, Partners Group Holding AG and Kedaara Capital, two private equity firms that hold it, would be able to reduce their ownership stakes through the IPO. The people claimed that other banks will probably be brought on board to work on the IPO. According to them, the Gurugram-based business might raise anywhere from \$850 million and \$1 billion through the IPO. Partners Group, Kotak, ICICI, and Vishal Mega Mart did not immediately respond to requests for comment made outside of business hours, while a spokesman for Kedaara declined to comment. In 2018, investment firm TPG Capital sold Vishal Mega Mart to Switzerland-based Partners Group and Indiafocused private equity firm Kedaara for an undisclosed sum. KOLKATA: The hot and discomfort weather conditions in the past few days are taking a toll on the health of Kolkatans, especially those who have to remain outdoors for hours. Even though none of the city hospitals have recorded any heat stroke cases so far, doctors are getting a good number of people with heat exhaustion and dehydration. Health experts have cautioned people to take all precautions when outdoors to avoid severe consequences.

"Because of such hot and humid weather, the people who are engaged in outdoor activities are prone to develop heat exhaustion when the body starts sweating a lot due to the rise of the core body temperature resulting in dehydration.

Heat exhaustion makes the person feel weak, dizzy and thirsty. I have seen two to four such cases in the past one week, mostly middle aged men, probably due to their higher exposure to the sun," said internal medicine specialist Joydeep Ghosh of Fortis Hospital, Anandapur. opd



Joyride? Man risks life travelling 400km on the train's roof

KANPUR: A man spotted lying on the roof of New Delhi-Gorakhpur bound Humsafar Express (12572) triggered panic at the Kanpur Central railway station on Tuesday.

Investigation revealed that the man, identified as Dilip Kumar of Fatehpur, had travelled an astonishing 400km between Delhi and Kanpur by lying on the train's roof. The video of his bizarre act also went viral on social media. Fortunately, Kumar did not stand on the train's roof during the journey and got saved from getting electrocuted by the overhead wires, said GRP personnel.

When the train entered platform 9 of Kanpur Central, passengers noticed Dilip on the roof of the B-11 AC coach of the Humsafar Express and raised an alarm.

LUCKNOW: UP govt's Varanasi farm has become the country's first conservation centre to breed two high-merit Gangatiri cow calves using embryo transfer technology (ETT) and IVF. The two female calves were born on March 26 and 27.

Gangatiri breed is native to eastern UP and Bihar. It got its name after Ganga as it is the belt along the river which is its natural habitat.

The breed has low input costs and is resistant to many diseases."Gangatiri is recognised nationally and has high significance as a source of livelihood to local farmers in the state," said Dr Neeraj Gupta, CEO of the UP Livestock Development Board. The ETT will help produce elite cows at a faster rate as a single mother can produce multiple highmerit progenies, he added. In the current case, four elite females at the farm were selected as egg donors. Semen from a high-merit bull was used to fertilise the eggs in-vivo (inside the body).



After about seven days, the embryos were flushed from the donor cows and transferred into four surrogate cows, which may not have been of high merit. However, only two pregnancies were successful, and two calves were born, said Gupta. The ETT is being extensively used for the improvement of indigenous cow breeds at var-

ious places as elite cows are used as egg and sperm donors.

"This technique will increase the efficiency as well as productivity of Gangatiri bovine herds . It has huge potential to multiply the income of farmers," said Ravinder, principal secretary of animal husbandry, dairying and fisheries, and chairman of UPLDB.

Ferozepur: A youth was lynched by a mob after he was accused of tearing the Guru Granth Sahib at a gurdwara in Bandala village, Ferozepur district, Saturday. 

Jaleel to contest from Aurangabad, says Owaisi

Jaleel to contest from Aurangabad, says Owaisi Chhatrapati Sambhajinagar: Putting an end to speculations of Aurangabad MP Imtiaz Jaleel contesting the Lok Sabha polls from Mumbai, All India Majlis-E-Ittehadul Muslimeen (AIMIM) president Asaduddin Owaisi on Monday announced Jaleel's candidature from Aurangabad again. Owaisi took to X and announced that his party's Bihar president Akhtarul Iman would be the party's candidate from Kishanganj (Bihar) and Imtiaz Jaleel would contest from Aurangabad.

Owisi himself will contest from Hyderabad. During a media interaction in Hyderabad, Owaisi said: "In addition to these three candidates, party's state presidents in Maharashtra, Bihar and Uttar Pradesh are working on finalising the number of seats to be contested. We will make an official announcement." When contacted, Jaleel said: "I thank the people of my constituency for letting me represent them in Parliament for five years. I did my best to raise the voice of the common people and fought hard against the wrong govt policies. Now, I will again approach people and if they feel I have done good work, then they would definitely stand with me. My initial two years as MP were lost because of Covid. Hope people will give me an opportunity to continue serving them." Jaleel, after winning the MLA elections in 2014, contested and won the LS elections against Shiv Sena's Chandrakant Khaire with a narrow margin in 2019 elections. He had openly expressed desire to contest the upcoming Lok Sabha polls from Mumbai .(North Central). Jaleel had cited communal violence on Thane's Mira Road during the Ram temple consecration, followed by civic body's action of demolishing several 'encroachments.
