Himachal Pradesh CM Sukhvinder Singh Sukhu successfully quelled rebellion within his govt on Wednesday as Vikramaditya Singh, son of former CM late Virbhadra Singh, retracted his decision to resign from the council of ministers.Sukhu was in trouble following cross-voting by six Congress MLAs, enabling BJP to secure victory in Rajya Sabha polls in the hill state the previous day. The crisis intensified Wednesday morning when Vikramaditya, the 34-year-old son of state PCC chief Pratibha emotionally announced his resignation during a press conference at the assembly

### Indian team boycotts Thai representatives at WTO talks

ABU DHABI: A comment by Thailand's ambassador to WTO Pimchanok Vonkorpon Pitfield, accusing India of using 'subsidised' rice procured for the public distribution system for capturing the export market, has created a diplomatic storm with govt lodging a strong protest and Indian negotiators refusing to participate in some deliberations in groups where a representative from the southeast Asian country is present.The Thai ambassador's comment on Tuesday during a consultation meeting was cheered by some representatives of rich nations, angering the Indian delegation here. Thailand is seen to be fronting for the US, European Union, Canada and Australia, among others, which have blocked a permanent solution to public stockholding for over a decade.

Officials said a strong protest has been lodged with the Thai govt and commerce and industry minister Piyush Goyal took up the matter with USTR Catherine Tai and EU executive vice-president Valdis Dombrovskis, making it clear that the language and behaviour were unacceptable. Govt officials told the Thai ambassador had got all her facts wrong as only around 40% of the produce is procured by govt to meet food security obligations. A part of the remaining quantity, which is not procured by govt agencies, is exported from India at market price.

#### 'Terms of trade favour rich nations'

In recent years, the share of Indian rice in the global market has gone up and the recent export curbs have angered western nations. Developed countries have been trying to paint a picture that India was distorting global trade by selling subsidised foodgrain in the international market, which was not the case. On the contrary, officials pointed out that the rules were framed in a way that the terms of trade favoured rich nations with the reference price for calculation of subsidy fixed.

# Rapes, molestations unearthed at **Gujarat National Law University**

Terming the report "really scary", a bench of Chief Justice Sunita Agarwal and Justice Aniruddha Mayee Wednesday blasted GNLU for the incidents and said the varsity's administration was involved in suppressing voice of students.

HC had taken suo motu cognisance of media reports following social media posts that a girl in

### Two-child norm for govt jobs in Rajasthan gets **Supreme Court nod**

NEW DELHI: More of Rajasthan Police

than 21 years after upholding validity of the mandatory 'twochild norm' eligibility criteria for candidates contesting panchayat polls, the Supreme Court has now put its stamp of approval on an identical norm for public employment, debarring candidates who have more than two children from seeking govt jobs.A bench of Justices Surya Kant, Diapankar Dat. ta and K V Vishwanathan dismissed the appeal filed by ex-serviceman Ram Lal Jat, who had retired from service in 2017 and had applied for a constable's post in Rajasthan Police on May 25, 2018.

His candidature was rejected as Rule 24(4) Subordinate Service Rules, 1989 that followed the norm set under the Rajasthan Various Service (Amendment) Rules, 2001, which provides "no candidate that shall be eligible for appointment to the job who has more than two children on or after June 1, 2002." He had unsuccessfully challenged the rejec-

tion of his candidature for constable post in Rajasthan high court, which in Oct 2022 had ruled that the fixation of norms squarely fell in the realm of policy, which could not be interfered with by the court. The Justice Kantled bench said, "A somewhat similar provision.

### Not the first time the Indian Navy has come to the aid of distressed vessels



**NEW DELHI:** Amid a series of attacks on vessels, the Indian Navy once swung into action after Iranian Fishing Vessel FV Al Arifi made a distress call.Responding to the distress call from the fishing vessel, the Indian Naval ship INS Mission, Shivalik deployed in the Gulf of Aden, rendered medical assistance including critical medical supplies to the 18 Pakistani crew onboard. "INS Shivalik is deployed in the region in consonance with the Indian Navy's mandate of Maritime Security Operations

This is not the first time the Indian Navy has come to the aid of distressed vessels. Earlier this month, an Indian Naval ship mission deployed in the North Arabian Sea for maritime security operations provided damage control assistance to the Iranian Fishing Vessel (FV) Ameen, with six Iranian crew onboard, operating East of Duqm. Medical aid was also extended to three injured crew under the broader members. The FV sus-

tained extensive damage, including a hull breach leading to water ingress.Earlier in January, Indian warship INS Sumitra rescued hijacked Iranianflagged fishing vessel Al Naeemi with 19member Pakistani crew off the east coast of Somalia. In the same month, the firefighting team of INS Visakhapatnam successfully controlled a fire onboard the merchant vessel Marlin Luanda. The Indian prompt Navy's response and collaboration with the merchant vessel's crew ensured the fire was brought under con-

# WTO meet: India seeks permanent solution to food security

**NEW DELHI:** India will strongly oppose a China-led proposal for an investment facilitation pact besides pressing for finding a permanent solution to public stock holding of grains for food security and protection of the interests of fishermen at the WTO ministerial meeting beginning Tuesday. The Indian delegation is led by Commerce and Industry Minister Piyush Goyal. The four-day 13th ministerial conference (MC13) will start on February 26 in Abu Dhabi, the United Arab Emirates (UAE).

Trade ministers of 164 member countries of the World Trade Organisation (WTO) are meeting against the backdrop of the uncertain global economic situation due to the Red Sea crisis, the Ukraine-Russia war and the Israel-Hamas conflict. The key issue of India's interests at the meeting relates to finding a permanent solution for its minimum support price (MSP) issue for food security, agricultural reforms, fisheries subsidies, e-commerce moratorium on import duties, dispute settlement, and WTO reforms.

Food security issues The public stock-holding (PSH) programme is a policy tool under which the government procures crops like rice and wheat from farmers at MSP, and stores and distributes



foodgrains to the poor.

India stresses the need for PSH for its large, vulnerable population and wants a permanent solution from the MC13. Food procurement, stockholding, and distribution are crucial to India's food security strategy. MSP is normally higher than the prevailing market rates and sells these at a low price to ensure food security for over 800 million beneficiaries. the However, WTO's Agreement on Agriculture limits the ability of a government to purchase food at MSP. Under global trade norms, a

WTO member country's food

subsidy bill should not breach

the limit of 10 per cent of the

value of production based on the reference price of 1986-88. As part of the solution, India has asked for measures like amendments in the formula to calculate the food subsidy cap. Developed nations are of the view that such programmes distort global trade prices of food grains.

Joint Support Initiatives (JSIs) or plurilateral agreements

India opposes this move being pushed for certain nations. For example, India is strongly opposing efforts of a group of countries led by China to push a proposal on investment facilitation for development agreement at the WTO.

The country has maintained

that this agenda falls outside the mandate of the global trade body. According to experts, the attempt of the group to integrate the proposal into the WTO has systemic concerns for the organisation and it would impact developing nations in pursuing their interest in future.

#### Agricultural reforms

India's stance is to protect farmer livelihoods and ensure equitable market access. However, developed nations are pushing to reduce domestic support and increase market openness irrespective of the fact that they themselves provide large subsidies to their rich farmers.

# 'It's being addressed': US diplomat Richard on action against Pannun

NEW DELHI: The US deputy secretary of state, Richard Verma, has assured that the United States will take action against India-designated terrorist Gurpatwant Singh Pannun and his associates if they cross the line.In an interview with ANI on Tuesday, Verma said, "I'm not going to get into specific cases, but I just go back to what I said about operating within the law. When people cross that line, they will be held accountable."

Verma also said, "When people say things, and we each have different rules when it comes to free speech. We have to assess where the line crosses into conduct, but we won't tolerate any violence or any kind of harassment directed at officials, and we will crack



down on it where the law allows us to do it, and we have done it, and we will continue to do it." Regarding the alleged involvement of India in the attempted assassination of Gurpatwant Singh Pannun, the US deputy secretary of state said, "Look, we raised the concerns with the Indian government at the most senior levels. They took it seriously. They've launched an investiga-

tion, and we look forward to continuing to hear back from the Indian authorities about what they've found, but it's a very important issue, and it's being addressed."

Gurpatwant Singh Pannun, an India-designated terrorist holding American and Canadian citizenship, has been charged with murder-for-hire. The US Justice Department revealed that an Indian national, Nikhil Gupta, has been charged for attempted 'murder-for-hire' of Pannun. The US government is waiting for the committee of inquiry set up by India to provide updates on the investigation. Verma said, "Well, as I understand, there is a committee of inquiry that's looking into this and investigating.

Delhi: Navjot Singh Sidhu's comeback to the BJP and Yuvraj Singh's Gurdaspur parliamentary constituency nomination are causing a stir. Even though Sidhu has criticized the Centre's farmer policies, rumors persist. Sidhu, known for his oratory, has been at odds with Congress's Punjab leadership and hosting his own rallies, defying party orders. BJP leaders in Majha believe Sidhu might rejoin his parent party and run for



Lok Sabha from Punjab, despite his close relations to Rahul Gandhi and Priyanka Gandhi Vadra. He stated BJP leaders and possible candidates are dis-

# **Courts cannot direct states to** implement particular schemes

**NEW DELHI:** The scope of judicial review in examining policy matters of the government is very limited and the courts cannot direct the States to implement a particular policy or scheme on the grounds that a "better, fairer or wiser" option is available, the Supreme Court has said. The observation came while disposing of a PIL seeking formulation of a scheme on setting up of community kitchens to combat hunger and malnutrition. The top court refused to pass any direction in the matter observing that the National Food Security Act (NFSA) and other welfare schemes are being implemented by the Centre and states. A bench of Justices Bela M Trivedi and Pankaj Mithal said legality of the policy, and not the wisdom or soundness of the policy, would be the subject of judicial review. "It is well



settled that the scope of judicial review in examining the policy matters is very limited. The courts do not and cannot examine the correctness, suitability or appropriateness of a policy, nor are the courts advisors to the executive on the matters of policy which the executive is entitled to formulate. The courts cannot direct the States to implement a particular policy or scheme on the grounds that a bet-

ter, fairer or wiser alternative is available," the bench said. The apex court said it was open to states and union territories to ensure implementation of alternative welfare schemes. "When the National Food Security Act (NFSA) with a 'right based approach' for providing food and nutritional security, is in force and when other welfare schemes under the said Act have also been framed.

### Modi govt did for India-Greece ties what others didn't in 40 years

Greek Prime Minister Kyriakos Mitsotakis will be the chief guest at the annual Raisina Dialogue held in New Delhi from 21 to 24 February 2024. This would be the third consecutive year of having a European guest at the summit — Delhi hosted European Commission president Ursula Von der Leyen in 2022 and Italian PM Georgia Meloni in 2023. The business delegation accompanying Mitsotakis will visit Mumbai and Bengaluru as well and is likely to explore economic opportunities in sectors such as construction material manufacturing, food and beverages, defence, renewable energy sources, high technology, agriculture, shipping, and tourism. Mitsotakis' visit marks a significant upgrade to India-Greece bilateral ties. It also builds on Delhi's strategic outreach to Southern Europe and the Mediterranean within the expanding diplomatic footprint in Europe at large. India and Greece are among the world's oldest democracies, both being ancient cultures and civilisations that reinvented their ethos through various epochs. Early Greeks knew of the river Ganges and called it Phison and the great Greek political philosopher Plato knew of the Indian tradition of mystic meditations. The latter's celebrated work The Republic concludes with a reflection on the transmigration of souls, which has an indelible mark of Indian spiritualism. From Mauryan-era trade to the fascinating chronicles of Alexander the Great, linkages with Greece were significant in ancient India. Despite sharing such a rich history of economic and cultural exchanges, the ties between the two countries never moved beyond a point. PM Narendra Modi has carved the space to upgrade the ties between the two countries to a strategic partnership that's suitable to today's fastchanging geopolitical context. His efforts have opened up newer pathways of cooperation amid fresh challenges. From India's perspective, Greece was the only natural ally with whom strategic cooperation had not been given the same attention as Cyprus, Italy, Spain, and France. For the first time in 40 years, an Indian PM visited Greece when Modi went to Athens in August 2023, where he was rightly conferred with Greece's Grand Cross of the Order of Honour, the country's second-highest civilian honour. This upgradation to a strategic partnership was built on the groundwork laid by External Affairs Minister S Jaishankar in 2021 when he paid an official visit to Greece. The following year, the Greek parliament ratified the International Solar Alliance (ISA), a treaty-based organisation that was proposed by Modi in 2015. In March 2022, Jaishankar's visit was returned by his then-Greek counterpart Nikos Dendias. This slew of developments has been instrumental in enhancing ties between the two countries. It opened new vistas to expand areas of convergence in not only trade and joint military exercises but also connectivity projects, which could help in the full utilisation of Greece's strategic location as a gateway to Europe for India and the Gulf countries. The much-touted India-Middle East-Europe Economic Corridor (IMEC) was conceived on the same logic of connecting diverse geographies of South and West Asia to Europe through Haifa in Israel and Piraeus in Greece. The region is a prospective yet contested pathway for new, competing intercontinental connectivity corridors. Many wrote off the IMEC when Hamas' brutal attack on Israel on 7 October 2023 put the normalisation process on hold. But remarks made by Indian finance minister Nirmala Sitharaman in Parliament and Modi in the United Arab Emirates have roused fresh interest in the project. It is likely to be back on track once the situation in the Middle East improves. Northern Cyprus declared independence in 1983 with Turkish support, sealing the fate of the region in a perpetual disquiet – the power balance in the Eastern. Mediterranean has been fragile

# India and the problems with Chinese manufacturing

Manufacturing overcapacity is a cause of concern for any economy. However, it has wider global ramifications. For instance, the US steel industry also went through this phase. In the 1970s and 1980s, the US steel industry experienced significant overcapacity. Despite declining demand for steel in the United States due to various economic and technological changes, steel manufacturers continued to produce at high levels. This overproduction led to a glut of steel in the market, causing prices to plummet and profits to erode. The industry's overcapacity resulted in severe consequences, including widespread plant closures, job losses, and a long period of economic hardship for communities reliant on steel production. The situation was exacerbated by the industry's slow response to global competition and technological innovation, which made it difficult to adjust to the changing market conditions. Relating this to the current situation of manufacturing overcapacity in China, we see parallels in the potential for economic disruption. Like the US steel industry, China's aggressive expansion in manufacturing capacities, particularly in green goods like EVs and solar panels, is creating a surplus that exceeds both and global domestic demand. This overcapacity



risks leading to similar outcomes as those experienced by the US steel industry, including price pressures, reduced profitability for manufacturers, and potential trade tensions as other countries respond to the influx of cheap Chinese products. The situation is compounded by subsidies and state support, which can distort market signals and lead to inefficient allocation of resources.

But why is this happening now? The answer is simple. Chinese lending is shifting from the property sector to manufacturing, leading to concerns about overcapacity. Within a span of less than four years, Chinese banks have transitioned from granting over one trillion dollars in new loans annually to the property sector to observing a net reduction in outstanding debt for the first time since records began in 2005. In contrast, the third quarter of 2023 saw these banks extend nearly \$700 billion in new loans to the manufacturing sector, often at interest rates below market levels. This surge in lending has facilitated the rapid expansion of new manufacturing facilities across China, specializing in products like electric vehicles (EVs) and batteries.

However, with domestic consumption not being able to fully absorb this increased production, there are reports of China dumping this overcapacity in the international markets. In the lithium-ion battery cell industry, for example, the expansion has surpassed demand, leading to predictions of industry consolidation. The utilisation rates of gigafactories, which are crucial for battery production, were at 45 per cent in 2022 and have further declined in the first half of 2023, highlighting the extent of the overcapacity problem. The oversupply has led to drastic price reductions in key components, such as

lithium carbonate, a critical by intensifying the original material for rechargeable batteries. Prices have plummeted more than 80 per cent from their peak, which has had a significant impact on the profitability and sustainability of companies within the sector. It's becoming increasingly evident that this maneuver may not be merely an economic realignment but could also be construed as a calculated move by China to unsettle global market dynamics. This development demands a closer examination, as its repercussions extend beyond national borders, challenging the equilibrium of international trade and industry competition. In fact, the US has recently warned Beijing against dumping goods on global markets as it fears China would be easing domestic overcapacity with cheap exports. However, addressing overcapacity has become a persistent challenge within Chinese industrial strategies. This issue, akin to a resilient virus, proves tough to eradicate and necessitates ongoing efforts to manage. Typically, this involves state-led consolidation of industries, which results in the elimination of less competitive firms. The survivors, having weathered the storm, emerge stronger and more aggressive, particularly in international markets, there-



The SWC 2 has capacity of 7 MLD and SWC 5 has 9.5 MLD capacity to treat sewage. The rejuvenation of storm water channels 2 and 5 to address the issue of drainage system, provide green space, add to the public amenities and beautifv the Dwarka sub-citv. SWC2 and SWC5 Channels pass through many sectors (8, 9, 20, 23, 19, 24 and Sectors 3, 13, 14, 16) of Dwarka before merging with Najafgarh drain which further

into River Yamuna. SWC2 has length of 5.2 Km and SWC5 has a length of 3.8 Km. Over the past few years, these channels have been subjected to discharge of domestic waste waters adjoining colonies and other areas lacking sewerage facilities. The channels became open sewers and resulted in inhospitable situations in the nearby areas. To address these pollution issues and boost the overall environmental wellbeing, DDA executed this project to rejuvenate the channels by sewerage interception and treatment along with area

# RIL-backed AI model set to launch in March

A consortium backed by Ambani's Mukesh Reliance Industries and the country's top engineering schools aim to launch its first ChatGPTservice next month, a big step in the country's ambitions to become a player in the field of artificial intelligence.The BharatGPT group - encompassing an arm of India's most valuable company and eight affiliated universities offered a sneak peek of the large language model on Tuesday during a technology conference in Mumbai. In a video played before delegates, a motorcycle mechanic in southern

India queried an AI bot Infocomm and govt. in Tamil, a banker conversed with the tool in Hindi, and a developer in Hyderabad used it to write computer code. If successful, the model dubbed Hanooman - will represent an advance for India in the accelerating race to develop potentially transformative Al technology. BharatGPT envisions the model working via 11 local languages in four main fields: health care, governance, financial services and education. It developed the model in collaboration with the IITs including in Bombay, backed by wireless carri-Reliance

A swath of startups such as Sarvam and Krutrim, backed by prominent VC investors such Lightspeed Venture Partners and billionaire Vinod Khosla's fund, are also building opensourced AI models customised for India. While Silicon Valley companies like OpenAI are building ever-larger LLMs, those efforts involve workarounds because of computational straints and simpler models affordable to smaller businesses and govt departments.

"It's a different genre of LLMs," said Ganesh Ramakrishnan.

### PPP approach for Badli industrial maintenance

Delhi: The Delhi government will hire a concessionaire to redevelop and maintain Badli industrial area on a public-private partnership. Officials said the Delhi State Industrial and Infrastructure Development Corporation (DSIIDC), which maintains 29 planned industrial pockets in the capital, is hiring a consultant to identify critical gaps and suggest the best maintenance model. In recent months, Delhi government-owned DSIIDC has redeveloped and maintained regulated industrial sites. An independent engineer will maintain civic amenities and infrastructure in the Bawana industrial area, while facility management companies will maintain the Patparganj and Okhla phase-III industrial pockets and a consultant will identify critical infrastructure gaps in the Bhorgarh industrial area in the capital. For Badli, officials stated a transaction advisor will examine industrial infrastructure facilities and identify crucial infrastructure gaps by knowing industrialists' unit requirements. An official said the consultant or transaction adviser will suggest an effective, economically viable, technically practicable, and implementable plan for Badli industrial area growth and management based on the assessment and understanding. A complete infrastructure assessment and development plan for vital infrastructure such as internal roads, storm water drains, parking, horticulture, and lamps would be done by the consultant, officials added. The consultant must also recommend and assist DSIIDC in implementing a Badli maintenance model. The Badli industrial area, 78 acres in northwest Delhi, includes three phases, with phase 3 opening in 1998. Officials said most basic utilities including roads and stormwater drains were in place.

# Fintech loan defaults drop to pre-Covid level: Report

MUMBAI: Loans provided by fintech companies through digital platforms, which are overdue for more than 90 days, constitute 3.6% of their total portfolio as of Sept 2023, according to a study released by Fintech Association for Consumer Empowerment. The delinquency ratio has shown improvement since reaching a peak of 11.1% in March 2021 and is now better than the pre-Covid level of 3.9% as of March 2020. West Bengal has the highest delinquency rate for digital loans at 4.3%, followed by Rajasthan at 4%, and Uttar Pradesh and Maharashtra tied for the third spot at 3.9%. 
