NEW DELHI: Ruling out any possibility of returning to ballot paper, Supreme Court on Thursday said there was a huge drawback with that system and use of EVMs had stood the test of time with rising voting percentage reflecting voters' faith in them.

As questions were raised on functioning of EVMs and the possibility of them being tampered with, a bench of Justices Sanjiv Khanna and Dipankar Datta asked the petitioners not to be "oversuspicious" and appreciated the Election Commission's efforts to clarify doubts about the functioning of the machines.

PUNE: NCP (SCP) chief Sharad Pawar's daughter and outgoing Baramati MP Supriya Sule is a crorepati 100 times over but owes opponent and sisterin-law Sunetra Pawar Rs 35 lakh, their poll affidavits reveal. Also, Sule carries the debt despite being richer. In her affidavit filed

Thursday, Sule says she also owes Rs 20 lakh to Parth Pawar, the son of Sunetra and Ajit Pawar, Maharashtra deputy CM and Sule's cousin. The debt had found a mention in Sule's 2019 affidavit as well, which means it has still not been cleared.

In her affidavit as the candidate, NCP Suntera has confirmed Sule's loan. That's not all. Sunetra also claims she lent Rs 50 lakh to Sule's mother Pratibha (Sharad Pawar's wife) and that it is yet to be repaid. Both Sule and Suntera have declared wealth of more than Rs 100 crore. Sule's family's total assets (movable and immovable)

Sanand, Kalol and Ahmedabad, all segments of Shah's constituency, had large crowds waving BJP flags and shouting slogans of "Jai Shri Ram" and "Bharat Mata Ki Jai" as their local MP waved at them from an open-top vehicle. He will file his nomination papers at the Gandhinagar collectorate on Friday. 



India tests long-range cruise missile for precision-strike capabilities

NEW DELHI: India on Thursday tested the indigenous technology cruise missile (ITCM), with a strike range of 1,000-km, from the Chandipur integrated test range off the Odisha coast. This subsonic long-

range land-attack cruise missile, with a canister-launch system, will eventually be one of the mainstays of the tri-service Integrated Rocket Force to be raised for conventional (nonnuclear) combat capabilities and deterrence.The missile's performance Thursday, powered by the indigenous Manik turbofan engine instead of the earlier Russian one, was monitored by several radars, electro-optical tracking systems and

telemetry sensors



The flightpath of the missile, which is a derivative of the original Nirbhay missile with indigenous systems, was also monitored by Sukhoi-30MKI fighters. "All subsystems performed as per expectation. The missile followed the desired path using waypoint navigation and demonstrated a very low altitude sea-skimming flight," a DRDO

official said.

"This successful flighttest also established the reliable performance of the indigenous propulsion system developed by the Gas Turbine Research Establishment, Bengaluru. The missile is equipped with advanced avionics software to ensure better and reliable performance. The overloaded bridge: A race against time

Varanasi: The Shastri Bridge, situated in the heart of Mirzapur, is a vital link connecting bustling cities. However, beneath its sturdy exterior lies a ticking time bomb. With each overloaded truck that rumbles across, the bridge's very existence feels precarious, as if it's on the brink of collapse. Despite multiple repairs, the bridge remains strained and groaning under the weight.

Now the question arises; will all the engineers responsible for its maintenance be able to save it from a major catastrophe before it's too late? Continuous overloading has turned the Shastri Bridge into a

significant threat, necessitating the establishment of active monitoring posts to ensure its safety. Immediate action is imperative in this regard.

In light of the precarious state of the Shastri Bridge in Mirzapur, commuters must consider safer alternatives, such as NH2 (currently named National Highway 19 or NH19), leading towards the Varanasi Toll. This alternate route offers a viable option for travellers to divert from the overloaded Shastri Bridge, thereby reducing the risk to their safety and that of their loved ones.

There's no denying that the government is actively focused on the development of foundational structures. Consequently, development and connectivity in the region are on the rise. However, the success of development projects heavily relies on vigilance and timely maintenance to ensure the longevity and safety of crucial assets. Shastri Bridge in Mirzapur is also one such property. Regular inspections of the bridge are necessary to keep its structure secure over the long term.

The Shastri Bridge over the Ganga in Mirzapur is currently facing the challenge of overloading, despite undergoing several repairs. This raises serious concerns about

the safety of both the bridge itself and the lives of those who use it. The bridge, constructed in 1976, is now nearly 50 years old and has undergone three rounds of repairs. In the year 2021, the bridge was repaired for Rs 4.62 crore. The repairs included the replacement of bearings and beam grouting. Additionally, the work of carbon fibre wrapping and cable grouting has been completed on 28 spans (parts) of the bridge.

Mr. R.S. Upadhyay, the Project Manager of the Bridge Corporation, revealed that according to the load testing report of 2021, the traffic was

deemed safe as per standards. Despite all efforts, a malfunction occurred within four months. The result was that the movement of empty trucks was stopped. Eventually, in November 2022, the bridge was closed. Considering the situation, an additional budget of ?7.48 crore was allocated for further repairs, and the restoration commenced in June 2023. After five months of work, the bridge reopened on 23 November, with previous issues reportedly resolved. However, concerns persist regarding the bridge's long-term maintenance and safety. Even now overloaded vehicles continue to

move on the bridge without any proper inspection, posing a serious risk to the safety

of the bridge and its users. Taking into account the current issues with the existing bridge, the government has recently approved the construction of a six-lane bridge and a bypass. This bridge will connect Mirzapur to several major cities in Uttar Pradesh and Madhya Pradesh. This underscores the necessity for officials to establish regular inspection checkpoints and maintain continuous monitoring to ensure the safety of the bridge's structure and the communities around it.

Atiq's sons to be interrogated over missing Beretta pistol used in Umesh Pal murder

lice are preparing to interrogate the sons of the late Mafia-politician Atiq Ahmed, Ali and Umar, currently held at Naini Jail and Lucknow Jail respectively, regarding the whereabouts of a missing Beretta pistol allegedly used in the murder of Umesh Pal.

During a police raid on March 21, 2023, a sophisticated foreign-made Colt firearm was discovered in

other firearms and ammunition. Subsequently, British Bulldog and Walther pistols also were recovered from Atiq's son Asad Ahmed and his associate Ghulam after they were killed in an encounter in Jhansi on April 13, 2023. However, the Beretta pistol remains unaccounted for, prompting police interest in its retrieval. Ali and Umar will now face questioning concerning the gin of the firearms found.

Sophisticated firearms, among them a rifle used by the assailant Sabir, who is rewarded with Rs.5 lakh, were utilised in the murder of Umesh Pal and his two police guards. Additionally, Asad used an automatic pistol during the incident.

Following the incident, police teams unearthed a substantial cache of firearms and ammunition from office at Chakia, which included a colt pistol among other seized firearms. Moreover, just before Atiq and Ashraf were killed on April 15, another Colt pistol was recovered from a deserted location in the Kasari Masari area. This discovery also yielded ammunition, including cartridges of Pakistani origin.

SCHOOL CHALE HUM Twin effort to educate kids and elders in UP

Prayagraj: In the current upper primary school teachacademic session, 2024-25, adults too will repeat the slogan of School Chale Hum, besides small children. Officials of the UP Basic Education Department have instructed teachers and officials to run the Nav Bharat Literacy Program alongside the School Chalo Abhiyan in schools from Classes 1 to 8, for the first time. The Nav Bharat Literacy Program is aimed at imparting basic education, digital and financial literacy and critical life skills to citizens aged 15 and above, who lost the opportunity to go to school, while the School Chalo Abhiyan is a campaign to enroll children into regular schooling.

Following the decision, during the household survey that is undertaken as part of these initiatives, the government primary and ers will have to record children aged between six and 14 years and enroll all the children not going to school, while also collecting the details of illiterate people above the age of 15 years in the households. Instructions have been

given to complete the household surveys by May 2024, officials of the state Basic education department said. A target has been given to make 25 lakh illiterate people literate across the state. For this, the scheme will be publicised on a wide scale in all 75 districts, officials added. Principal secretary, basic education, MK Shanmuga Sundaram, has given instructions to pay special attention to the survey of illiterate women, scheduled castes, scheduled tribes, minorities and disabled people, they said.

A favourable environment in support of the initiatives will be created by putting up slogans, organising street plays, taking out rallies, putting up posters, banners and hoardings at the Gram Panchayat level in all the districts. Nav Bharat Literacy Program and School Chalo Abhiyan will also be promoted through LED vans.

Contractual services depend on terms of contract: Alld HC

Prayagraj: Allahabad high court has held that an employee whose services are entirely contractual has no right to the post, and his service depends on the terms of the contract. Dismissing a writ petition filed by one Mahesh Kumar, a Safai Karamchari appointed on a contract basis, Justice JJ Munir observed, "In this case, the petitioner is not a temporary employee. He is an employee whose services are entirely contractual. Once that is the case, even if he has been selected through some kind of mechanism under a Government Order and appointed on contract, he has no right to the post. There is no lien. In fact, the Uttar Pradesh Government Servant Conduct Rules, 1956 would not apply to him because he is not an employee of the Nagar Palika, governed by those statutes or statutory rules. His terms

of service are governed by



petitioner's rights are governed exclusively by a contract that does not have any statutory flavour. It is a purely contractual appointment accepted by the petitioner without the rules and

without a lien on any post. The issue of whether the termination is in accordance with the contract or contrary to it, in the absence of a violation of any statute or statutory rules, or at least a statu-

tory contract, is not fit to be determined by this court in the exercise of our writ jurisdiction under Article 226 of the Constitution," he said.

The petitioner was appointed as a Safai

Karamchari, engaged on a contract by the Nagar Palika Parishad, Modi Nagar, Ghaziabad. He has challenged the order dated April 29, 2023, passed by the executive officer, Nagar Palika Parishad, Modi Nagar, Ghaziabad, by which his contract was terminated, and consequently, his service was terminated. India's security and the fencing of the Myanmar border

There are many naysayers who are of the vehemence that the fencing of the entire 1,643 km India-Myanmar border is not a good idea. Such personages — and they unfortunately include people such as a former Indian envoy to Myanmar — cite aspects ranging from the virtual end of the Free Movement Regime (FMR) which permits people living along the border on either side to travel 16 km into each other's country, without visa, for primarily trade to the human aspect pertaining to the demographic contiguity, that characterises both India and Myanmar in the borderlands. But if a dispassionate cost-benefit analysis of Union Home Minister Amit Shah's decision to fence the border is undertaken, then the pros will outnumber the cons. The ongoing turmoil in Manipur is a direct result of the open border with Myanmar. As I have written earlier in these columns, the Valley-Based-Insurgent Groups (VBIGs), including the United National Liberation Front (Koirang), the People's Liberation Front (Manipur), the People's Revolutionary Party of Kangleipak, the Kangleipak Communist Party and the Kanglei Yawol Kanna Lup (collectively known as the Group of Five (G-5), which is the new avatar of the Coordination Committee (CorCom) after the return of the United National Liberation Front (Pamei) to the mainstream, are billeted in three neat clusters in Myanmar's Sagaing Division. After the military takeover of February 1, 2021, the above underground groups came to an understanding with the Myanmar Army (MA). The VBIGs will no longer be touched, harassed or ousted from their safe havens in what has come to be known as the Northern, Central and Southern clusters in Sagaing Division. In return, the VBIGs would have to aid the MA to quell the civil unrest that erupted after the coup d'etat. The development not only led to an end to the modicum of military cooperation that had been witnessed in the years preceding the military takeover by way of Operations Sunrise-I and Sunrise-II, which demolished several India Insurgent Groups' (IIGs) camps in and around Taga (a hunting ground for IIGs just West of the Chindwin river), but the unprecedented situation in Manipur saw hordes of VBIG cadres entering Manipur to battle the Kukis and the security forces. The fact that the porous border also facilitated illegal migration, drugs and arms smuggling from Myanmar by social formations that had affiliations with people in Manipur and have begun to occupy forest lands in the state seems to be borne out by a plethora of facts. Also, several thousand anti-Junta rebels have fled to India since the February 1, 2021 military coup in Myanmar. Of late, even MA personnel had begun to enter Mizoram in a bid to escape the pursuing People's Defence Force (the National Unity Government's armed wing) and various ethnic militias. It is in this backdrop that I wish to examine the issue of the India-Myanmar border fence. At the very outset, it must be understood that fences are not walls. They are created to manage legal, regulated movement. I was an international visitor to the United States at the invitation of the US Department of State in 2003. One of the tours took 25 other law enforcers and conflict theorists from around the world as well to many places in the US including the US-Mexico border in San Diego. The manner in which the completely (and concretely, not merely fenced) sealed border is run has to be seen to be believed. We watched as US law enforcers carefully checked the credentials of Mexicans entering the

India and the problems with Chinese manufacturing overcapacity

Manufacturing overcapacity is a cause of concern for any economy. However, it has wider global ramifications. For instance, the US steel industry also went through this phase. In the 1970s and 1980s, the US steel industry experienced significant overcapacity. Despite declining demand for steel in the United States due to various economic and technological changes, steel manufacturers continued to produce at high levels. This overproduction led to a glut of steel in the market, causing prices to plummet and profits to erode. The industry's overcapacity resulted in severe consequences, including widespread plant closures, job losses, and a long period of economic hardship for communities reliant on steel production. The situation was exacerbated by the industry's slow response to global competition and technological innovation, which made it difficult to adjust to the changing market conditions. Relating this to the current situation of manufacturing overcapacity in China, we see parallels in the potential for economic disruption. Like the US steel industry, China's aggressive expansion in manufacturing capacities, particularly in green goods like EVs and solar panels, is creating a surplus that exceeds both domestic and global



demand. This overcapacity risks leading to similar outcomes as those experienced by the US steel industry, including price pressures, reduced profitability for manufacturers, and potential trade tensions as other countries respond to the influx of cheap Chinese products. The situation is compounded by subsidies and state support, which can distort market signals and lead to inefficient allocation of resources.

But why is this happening now? The answer is simple. Chinese lending is shifting from the property sector to manufacturing, leading to concerns about overcapacity. Within a span of less than four years, Chinese banks have transitioned from granting over one trillion dollars in new loans annually to the property sector to observing a net reduction in outstanding debt for the first time since records began in 2005. In contrast, the third quarter of 2023 saw these banks extend nearly \$700 billion in new loans to the manufacturing sector, often at interest rates below market levels. This surge in lending has facilitated the rapid expansion of new manufacturing facilities across China, specializing in products like electric vehicles (EVs) and batteries.

However, with domestic consumption not being able to fully absorb this increased production, there are reports of China dumping this overcapacity in the international markets. In the lithium-ion battery cell industry, for example, the expansion has surpassed demand, leading to predictions of industry consolidation. The utilisation rates of gigafactories, which

are crucial for battery production, were at 45 per cent in 2022 and have further declined in the first half of 2023, highlighting the extent of the overcapacity problem. The oversupply has led to drastic price reductions in key components, such as lithium carbonate, a critical material for rechargeable batteries. Prices have plummeted more than 80 per cent from their peak, which has had a significant impact on the profitability and sustainability of companies within the sector. It's becoming increasingly evident that this maneuver may not be merely an economic realignment but could also be construed as a calculated move by China to unsettle global market dynamics. This development demands a closer examination, as its repercussions extend beyond national borders, challenging the equilibrium of international trade and industry competition. In fact, the US has recently warned Beijing against dumping goods on global markets as it fears China would be easing domestic overcapacity with cheap exports. However, addressing overcapacity has become a persistent challenge within Chinese industrial strategies. This issue, akin to a resilient virus, proves tough to eradicate and necessitates ongoing

efforts to manage. Typically, this involves state-led consolidation of industries, which results in the elimination of less competitive firms. The survivors, having weathered the storm, emerge stronger and more aggressive, particularly in international markets, thereby intensifying the original problem. BYD is greatest example. It has become world's largest EV company, overtaking Tesla. The impact of this overcapacity is multifaceted. In Europe, the influx of cost-competitive Chinese EVs, for example, is threatening the continent's nascent EV production, prompting the European Commission to launch anti-subsidy investigations into imports of Chinese-made passenger battery electric vehicles. Similar concerns are arising in other green technology sectors, with potential for further trade disputes and investigations into China's dominance in clean energy supply chains, including wind turbines and heat pumps. Moreover, the situation in China's manufacturing sector is characterised by heightened volatility, with industries like steel and automobiles experiencing significant fluctuations in demand and profit margins. This volatility, exacerbated by the uncertain global economic environment since 2008.

KOLKATA: The hot and discomfort weather conditions in the past few days are taking a toll on the health of Kolkatans, especially those who have to remain outdoors for hours.

Even though none of the city hospitals have recorded any heat stroke cases so far, doctors are getting a good number of people with heat exhaustion and dehydration. Health experts have cautioned people to take all precautions when outdoors to avoid severe consequences.

"Because of such hot and humid weather, the people who are engaged in outdoor activities are prone to develop heat exhaustion when the body starts sweating a lot due to the rise of the core body temperature resulting in dehydration.

Heat exhaustion makes the person feel weak, dizzy and thirsty. I have seen two to four such cases in the past one week, mostly middle aged men, probably due to their higher exposure to the sun," said internal medicine specialist Joydeep Ghosh of Fortis Hospital, Anandapur. opd

B P Poddar Hospital had tended to 14 persons in its emergency in the past three days, most of them down with extreme dehydration making them unwell while they were out in the sun. "37 patients came to our OPD with heat related issues. While most of them were middle-aged patients, some were school children. We had to admit two senior citizens because in addition to dehydration they had other issues like BP fluctuation and sodium, potassium imbalance," said

Air India was fined Rs 1.10 crore by the DGCA for safety infractions

The aviation regulator DGCA fined Air India Rs 1.10 crore for operating Boeing 777 aircraft that were leased to the United States in breach of safety regulations. This is Air India's second penalty in a week from the regulator. A former Air India pilot filed a complaint with the regulator, claiming that the airline was operating Boeing 777 aircraft to the US without the necessary emergency oxygen supply system place. Directorate General of Civil Aviation (DGCA) conducted a thorough inquiry into the situation and served the airline with a showcause notice. "Since the said operations of the leased aircraft were not in line with regulatory/ OEM (Original Equipment Manufacturer) performance limits, DGCA has initiated enforcement action and imposed a penalty of Rs 1.10 crore on Air India," according to a notification from DGCA. Air India did immediately



respond to inquiries regarding the punishment. The announcement said that following receipt of a voluntary safety report by an airline employee accusing Air India aircraft on specific longrange terrain-critical routes of safety violations, the regulator conducted a thorough investigation. A showcause notice was sent to Air India, according to the DGCA, since the investigation's first findings suggested the airline was not in compliance.

cause notice in light of the performance limitations outlined in the documents provided by the OEM and the requirements outlined applicable under statutory provisions, the according to announcement. 

Complaining of shortage of medicines and inadequate lab tests in hospitals, mohalla clinics and dispensaries, Delhi Assembly on Friday passed a resolution demanding a solution to the issue within a week.

Legislative Assembly directed chief secretary Naresh Kumar to eliminate shortcomings in staterun health facilities and present a daily report to the health minister.

"A meeting of the Legislative Assembly will be convened on Friday, March 22, at 11 am, where the chief secretary will personally present a detailed report on this matter through the health minister," the resolution read. It was passed by a voice vote in the House. The resolution was brought after govt realised that a similar move last week to address water sewer-related issues had resulted in Delhi Jal Board acting on a war footing under



direct supervision of the chief secretary and resolving a large number of problems raised by MLAs across the city.

Health minister Saurabh Bharadwaj said the city's poor were distressed due to the shortage of medicines and laboratory tests in mohalla clinics, hospitals and dispensaries.

He told the House that medicines and other supplies are procured through a standard process and new tenders are issued every year before the current one expires. "A tender was issued for medicines on Dec 21, 2022. The officials

continued to conduct technical evaluations of that tender while previous one expired.

The current ten-

der is also expiring in March but the supplies of medicines have not been received," Bharadwaj said. Due to this, medicines are running out. "Why is no action being taken against the health secretary, director-general health services and officials of the central procurement agency who are obstructing the supply? Such officials should be prosecuted under the Criminal Bharadwaj said.

ED takes custody of tout Hiren Bhagat in PMLA

MUMBAI: There is more trouble for tout Hiren Romi Bhagat who along with his accomplices impersonated as officers of Enforcement Directorate (ED) threatened a developer and tried to extort Rs 164 crores. The special Prevention of Money Laundering Act (PMLA) court granted permission to the ED Mumbai office to take the custody of Bhagat, who is currently lodged in Arthur Road jail in connection with extortion cases. ED officials on Friday also intimated the 37th Metropolitan Magistrate regarding Bhagat's production warrant and late evening took Bhagat's custody from Arthur Road jail. The ED's probe is based on an FIR filed by the Mumbai crime branch against Bhagat and five others - Rajendra Shirsat, Rakesh Kedia, Kalpesh Bhosle, Avnish Dubey and Amesh Sawekar –who were arrested in December and Bhagat apprehended on January 21. Among the items seized are 13 kg of gold, 15 of the most expensive watches including Patek Philippe, foreign currencies equivalent to Rs 50 lakh, cash amounting to Rs 1.5 crore, documents relating to 18 high-end cars, property papers of 10 flats, and three automatic weapons: one MP-5, Beretta Tomcat, and Russian CZ-Scorpion. Additionally, extensive documents pertaining to the cases of EOW and ED have been found in searches of Bhagat's house and four bank lockers. Guidelines issued to make campuses inclusive for transpersons

MUMBAI: In an effort to make college campuses more inclusive, the state govt has for the first time come out with detailed guidelines for transgender students. Initiating action against colleges for refusing admissions on the basis of gender, reserving a section in hostels for transgender students and establishing cells to address issues of discrimination, mental harassment, sexual exploitation or any other violence against them, are some of the guidelines enlisted in the government resolution (GR) on Friday. The GR has come close on the heels of the govt's first-ever policy for transgender individuals approved by the cabinet earlier this

In December last year, the department had asked colleges and



universities to offer free-of-cost education to transgender students and bear their

tuition fees. Institutions have been asked to strictly follow the fee waiver policy in the new guidelines. These are in line with the National Education Policy, 2020, that speaks about making campuses inclusive for all students. A govt official said the department's policy was ready and since the state came out with its overarching policy, they also decided to release specific guidelines for higher

education institutions. To cater to the needs of all transgender students, colleges are expected to appoint coordinators to provide counselling, academic guidance and career advice. All nonagricultural universities, private and deemed universities and affiliated colleges in the state are expected to strictly follow the provisions of The Transgender Persons (Protection of Rights) Act, 2019, stated the guidelines.

Institutions need to adopt an inclusive policy to tackle issues of gender bias, negligence and segregation based on sexuality, it added. ensure equal opportunities for these students, institutions should organise awareness activities for both students and teaching/non-

teaching staff.

Cattle traders 'forced to pay protection money', lodge plaint

MUMBAI: The cattle traders have lodged a complaint that despite paying all the government taxes, including cattle taxes, they are forced to pay "protection money" to the goons on the highway.
